Dear Ms. Majolo:

Pursuant to C.R.S. § 24-4-103(11)(d)(II), the following corrections to the above-reference rule are not substantive changes, but are correcting typographical errors:

In the Statement of Basis and Purpose for Regulation 47.1-1901, \P 4(b), the "s" is being removed from "opens spaces" in the second line.

In the Statement of Basis and Purpose for Regulation 47.1-1902, \P 7, a period is being added after Ord in "Ord 220" and a comma is being removed after "220" in the first line.

In Regulation 47.1-1901(5), the extra "r" is being removed from "virture" and a comma is being added after "XVIII" in the last line.

In Regulation 47.1-1901(6)(q), the extra "to" is being removed from "to to the point of intersection" in the last line of the subsection.

In Regulation 47.1-1901(6)(ap), a comma is being added after "Thence" in the first line.

In Regulations 47.1-1901(6)(ay), (az), (ba) and (bb), the date the permanent rule became effective is being added in the last line of each subsection. Also in

subsection (ba), "bobtail" street is being capitalized in the second line and the "er" is being removed from "southerwestern" in the second line.

In Regulation 47.1-1902(5), a comma is being added after "XVIII" in the last line.

In Regulations 47.1-1902(6)(d),(e), (f), (g) and (h), a hyphen is being added to "seventy five" in the second line of each subsection.

In Regulation 47.1-1902(6)(y), the "a" is being removed from "to a the point of intersection" in the second line.

In Regulation 47.1-1902(6)(ab), the extra "t" is being removed from "interstection."

In Regulations 47.1-1902(6)(aj), (ak), (al) and (am), the semi-colon is being changed to a comma after "Thence" in the first line of each subsection.

In Regulation 47.1-1902(6)(ar), the extra "in" is being removed from "proceed in in an easterly" in the first line of the subsection.
