Pursuant to § 24-4-103(11)(I)(B), C.R.S., the following corrections to the above-referenced rule are occasioned by the General Assembly's relocation of **Title 12** to **Title 44** and such corrections meet the conditions specified in § 24-4-103(11)(I)(A), C.R.S.

The following are the citations that need to be corrected:

Statement of Basis and Purpose:

“12-47.1-103(15)” becomes “44-30-103(18)”;

“12-60-102(14)” becomes “44-32-102(11)”;

“12-60-102(26)” becomes “44-32-102(24)”;

“12-47-202(b)” becomes “44-3-202(b)”;

“12-43.3-104(3)” becomes “44-11-104(6)”; and

“12-43.4-103(4)” becomes “44-12-103(7)”.

Paragraph 2 – Definitions:

In Paragraph (2)(c), “47.1 of Title 12” becomes “30 of Title 44”;

In Paragraph (2)(e), “60 of Title 12” becomes “32 of Title 44”;

In Paragraph (2)(f), “47 of Title 12” becomes “3 of Title 44” and “12-3-408” becomes “44-3-410”;

In Paragraph (2)(g), “43.3 of Title 12” becomes “11 of Title 44”; and

In Paragraph (2)(h), “43.4 of Title 12” becomes “12 of Title 44”.
