RE: Correction of Motor Vehicle Dealer Board Regulations 1 CCR 210-2 (Motor Vehicle and Powersports Vehicle Manufacturers, Distributors, and Manufacturer's Representatives, and also Motor Vehicle Buyers Agents) Pursuant to Senate Bill 18-030

To whom it may concern:

On March 18, 2018, Governor Hickenlooper signed into law Senate Bill 18-030, *Concerning the Nonsubstantive Relocation of Laws Related to Self-propelled Vehicles from Title 12, Colorado Revised Statutes, as part of the Organizational Recodification of Title 12*. Senate Bill 18-030 serves the purpose of removing the statutory provisions for the motor vehicle and the powersports vehicle industries from Article 6 of Title 12 to Article 20 of Title 44. This relocation of the enabling statutes for the motor vehicle and the powersports vehicle industries renders all references to Article 6 of Title 12 within 1 CCR 210-2 no longer accurate. As a result, the proposed correction updates all statutory references from Article 6 of Title 12 contained in 1 CCR 210-2 to Article 20 of Title 44. The effective date for this update is October 1, 2018.

Pursuant to section 24-4-103(11)(I)(B), C.R.S., the following corrections to the above-referenced 1 CCR 210-2 are occasioned by the General Assembly's relocation of Article 6 of Title 12 and such corrections meet the conditions specified in section 24-4-103(11)(I)(B), C.R.S. and are nonsubstantive in nature.
