Adoption of new rules and regulations:

Rule 295—Regarding the Notification to the Board of Physical and Mental Illnesses or Conditions that Impact a Licensee's Ability to Practice with Reasonable Skill and Safety Pursuant to section 12-36-118.5, C.R.S.

The proposed rules under consideration are attached to this notice and fully incorporated herein. **The primary reason for this rulemaking hearing is to update the name of the Board, amend statutory citations and repeal rules no longer authorized or required due to statutory change. The Board will also engage in rulemaking pertaining to notification requirements for physical or mental illnesses or conditions that impact a licensee's ability to practice with reasonable skill and safety pursuant to section 12-36-118.5, C.R.S. These changes were necessitated by House Bill 10-1260, SB 10-124 and HB 10-1128.** The Board will also consider other proposed amendments, modifications and revisions, including but not limited to those reflected in the attached rules or other changes deemed necessary after considering written and oral comment.

The Board encourages interested parties to submit written comments to the letterhead address regarding any of the above-listed rulemaking matters no later than August 3, 2010. In addition, at the time and place designated in this notice, the Colorado Medical Board will afford interested parties an opportunity to submit written information, data, views or arguments. The Board also will afford interested parties an opportunity to make brief oral presentations unless the Board in its discretion determines that such oral presentations are unnecessary. All submissions will be considered. The rules under consideration may be changed or modified after public comment and hearing.
