 - o Anticipated scope of testimony, including the <u>specific proposed rules</u> on which the party or individual will testify
 - o Requested <u>length</u> of testimony <u>for each proposed rule</u> on which the party or individual will testify
 - Whether the party or individual intends to present documentary, audio, or visual evidence at the hearing, including any audio/visual presentation requirements

- Comments not designated as "testimony" will be made available to the Board prior to the hearing.

Order Governing Participation in the Rulemaking Hearing

- Mid October, 2017 The Hearing Officer will issue an Order governing participation of parties and individuals at the rulemaking hearing
- The Order will be distributed to the Stakeholders Listserv and all parties who submit a Notice of Intent to Participate, and posted on the DWR BOE Admin Rulemaking Website
- The Order will allot specific times for party testimony on each specific proposed rule
- Length of testimony allotted is reserved entirely to the discretion of the Board and Hearing Officer.
