

# Notice of Public Rule-Making Hearing Community Access Retail Delivery Fee March 10, 2022

NOTICE is hereby given pursuant to the provisions of § 24-4-103, C.R.S., that the Community Access Enterprise Board (the "Board") will conduct a public rulemaking hearing on <u>March 10, 2022 at 10:00 a.m.</u> to consider the promulgation of a rule to establish the community access retail delivery fee as required by § 24-38.5-303(7), C.R.S.

## Availability of the Agenda and the Proposed Rule

The agenda for the meeting and the proposed rule will also be available on the Board's website, <a href="https://energyoffice.colorado.gov/community-access-enterprise">https://energyoffice.colorado.gov/community-access-enterprise</a>, at least 7 days prior to the meeting. The proposed rule, together with the proposed statement of basis and purpose and specific statutory authority will be available for inspection at the Colorado Energy Office at least five working days prior to the hearing at the following address: 1600 Broadway, Suite 1960, Denver, CO 80202. Copies of the proposed rule may be obtained by contacting the Enterprise at ceo\_communityaccessenterprise@state.co.us.

#### Public Participation through Oral and Written Testimony

Testimony is limited to the subject matter and scope of the proposed rule. The Board encourages all interested persons to participate in the hearing by providing written data, views, or comments, or by making oral comments at the hearing during each individual's allocated time.

#### Written Testimony Encouraged

Submitting written comments or testimony prior to the rule-making hearing provides the Board an opportunity to identify outstanding issues and adequately prepare for the rule-making hearing. Written testimony may be submitted until 5:00 pm, Thursday, March 3, 2022; however, if you are able, please submit your testimony by 5:00 pm, Thursday, February 24, 2022. This gives the board ample time to review your testimony prior to the hearing. Information submitted by the deadline will be provided to the Board for review and consideration as part of the rule-making hearing.

### Oral Testimony Will Be Limited

The oral testimony will be limited. At the discretion of the Chairperson, oral testimony at the hearing may be limited to three minutes or less depending upon the number of persons who sign up to testify. Interested persons must sign up no later than 5:00 pm on Monday, March 7, 2022 by emailing your name and organization affiliation to ceo\_communityaccessenterprise@state.co.us. Requests for oral testimony can also be indicated in written testimony submittals. The time allocated for each person or group to comment on the proposal will be based upon the number of persons wishing to comment and the time allocated for the hearing, which will be two hours.

Depending upon the number of individuals that sign up to testify, some individuals may not receive an opportunity to provide oral testimony. Individuals or organizations that share the same perspective or position regarding the proposed rule are encouraged to identify one spokesperson to testify at the hearing. This is encouraged in hopes of preventing duplicative testimony and giving everyone the opportunity to speak. Persons appearing before the Board who wish to provide oral testimony are encouraged to prepare and use clear and concise language to explain their points of view. The Chairperson will limit duplicative or repetitive testimony, or testimony that is outside the scope of the proposed rulemaking in their discretion.
