
1. the Board hereby names [has named] RONALD CURRY as the Designated Election Official for the regular special district election scheduled for the 4TH day of May, 20 10 .

3. the Board further authorizes and directs the Designated Election Official to publish and post a Notice of Cancellation of Election at each polling place and in the offices of the Designated Election Official, the county clerk and Recorder of


each county in which the district is located, and file with the Division of Local Government. The Designated Election Official shall also notify the candidates that the election was cancelled and they are elected by acclamation.
