As chair of the Pueblo County Republican Party these are concerns our county has experienced in the past two elections from each of these points spelled out in Ms. Marks proposed rules document.

Since many of these points are all compelling and problematic it would be difficult to weigh which area merits the deepest concern; however established and proven residency would appear to be the most critical to the concept of election integrity.

Frequent replacement of the role of what should be appointed party judges to be replaced at random by clerk staff loyal to the county clerk and at the convenience of the county clerk defies the meaning and purpose of election judges being appointed by the appropriate democrat and republican party.

Poll watchers have frequently been blocked from viewing appropriate processes and in the past have not been able to access all areas of the appropriate stations in the election process and observed concerns have not been allowed to be vocalized and appropriate grievances not addressed satisfactorily.
