To Whom It May Concern:

On February 28, 2019, the Colorado Department of Agriculture (“Department”) filed notice of an adopted rule, 8 CCR 1202-16, “Rules Pertaining to Poultry Processing.” Unfortunately, the notice mistakenly contained a header with instructions related to the process in which the Department adopted the proposed rule. The header did not contain any substantive rule content and should not have been included in the final draft. The header contained the following text:
