Dear Secretary of State Griswold:

On May 30, 2020, the Colorado Division of Fire Prevention and Control ("DFPC") submitted SOS Tracking No. 2020-000396, Amendments to 8 C.C.R. 1507-31, Building, Fire, and Life Safety Code Enforcement and Certification of Inspectors for Health Facilities Licensed by the State of Colorado. The Rules became effective on August 14, 2020.

It has come to DFPC's attention that the adopted rule filed under this tracking number contains a minor error. In the last line of paragraph 13.2.4 (C), the citation should be corrected from "Article13.2.4(C)" to "Article 13.2.4(B)." See the paragraph below with the citation corrected.

- 13.2.4 A fee calculator posted on the Division website enables determination of total fees (plan review and construction permit fees) prior to submittal of a project.
  - A) Fees for Building Code reviews performed by the Division will be subject to a base fee of \$600.00 plus a fee equal to .0009 times the Total Project Valuation.
  - B) Fees for Fire and/or Life Safety Code reviews by the Division will be subject to a base fee of \$600.00 plus a fee equal to .0009 times the Total Project Valuation.
  - C) When both Building and Fire and Life Safety Code reviews are performed by the Division the Fees will equal the sum of both the Building review fees in Article 13.2.4(A) and the Fire and Life Safety review fees in Article 13.2.4(B).

This is not a substantive change, but rather a minor correction to a citation that was overlooked when DFPC made other amendments to these rules earlier this year. Correcting this typographical error improves clarity for readers.

On November 6, 2020, DFPC requested an administrative change to in order to correct the error designated above. The tracking number for the correction request is SOS Tracking No. 2020-00884.

This correction is technical and non-substantive in nature and is submitted to you for publishing in the C.C.R. pursuant to C.R.S. § 24-4-103(11)(d)(II) of the State Administrative Procedure Act.
