RE: Correction to Division of Lottery Rules, 1 C.C.R. 206-1 (Lottery Regulations)
SOS Tracking Number 2025-00011

Dear Secretary Griswold:

On April 2, 2025, the Colorado Department of Revenue, Division of Lottery, filed a Correction under SOS tracking number 2025-00146 for a rule promulgated by the Division of Lottery under 1 C.C.R. 206-1. This correction updates the version of the rules intended for inclusion in the Colorado register by including—in the final version—*other* changes to the same rules, which went into effect in the intervening period. The purpose of the correction is therefore to avoid confusion over the content of the rules following multiple amendments.

The Correction contains amendments to Rules 1 and 2. *See* attached Correction filed in SOS tracking no. 2025-00146; *see also* attached Adopted Rule filed in SOS tracking no. 2025-00011.

The corrections in Rules 1 and 2 are non-substantive in nature and meet the conditions specified in section 24-4-103(11)(d), C.R.S. On September 27, 2024, the Division of Lottery properly promulgated rules under SOS tracking number 2024-00487. *See* attached Adopted Rule filed in SOS tracking no. 2024-00487. These rules became effective on April 4, 2025—*after* the rules promulgated under SOS tracking number 2025-00011 were adopted (March 12, 2025). The technical corrections in Rules 1 and 2 are necessary to integrate the rules from the SOS tracking number 2024-00487 rules into the adopted rules submitted in connection with SOS tracking number 2025-00011.
