**Basis and Purpose:** The purpose of the proposed addition of Board Rule 3.05.00 is to specify the requirements for pharmacists when prescribing over-the-counter medications. The purpose of the proposed amendments to Board Rule 5.01.31 is specify who may transcribe a voice recorded order to writing and to allow a computer terminal or other device to be used a pharmacy personnel outside the compounding / dispensing area of a pharmacy but within the same location of the pharmacy under certain conditions. The purpose of the proposed amendments to Rule 5.01.40 and 5.01.50 is to address the minimum hourly operations and security requirements for a pharmacy when a pharmacy does not possess prescription drug or controlled substance stocks. The purpose of the proposed amendments to Board Rule 11.03.05 is to require and to address the requirements of a perpetual Schedule II controlled substance inventory in pharmacies. The purpose of the proposed amendments to Board Rule 11.04.10 is to allow for and specify the conditions in order for pharmacies to electronically maintain Schedule II controlled substance prescription orders. The purpose of the proposed amendments to Board Rule 11.06.00 is to eliminate the requirement to maintain a Drug Enforcement Administration (DEA) 222 Form when order the receipt of the corresponding drugs via the DEA's Controlled Substance Order System (CSOS). The purpose of the proposed amendments to Board Rule 14.02.30 is to require controlled substance inventories to be taken at each required consultant pharmacist visit at an Other Outlet. The purpose of the proposed amendments to Board Rule 20.00.90 and 20.01.00 is to allow a fulfillment pharmacy to deliver a prescription directly to the patient in lieu of returning the filled prescription to the originating pharmacy for dispensing to the patient of non-controlled substances. The purpose of the proposed amendments to Board Rule 21.00.20 is to clarify the requirements of nonresident pharmacies who wish to distribute compounded prescription drugs to Colorado-based licensed veterinarians under certain conditions. The purpose of the proposed amendments to Board Rule 21.20.70 is to clarify the use of velocity flow meters under certain conditions. The purpose of the proposed amendments to Board Rule 25.00.12 is to eliminate the requirement of a preregistration inspection of a specialized prescription drug outlet in order to obtain such a registration from the Board. The purpose of the proposed amendment to Board Rule 25.00.14 is to allow, and to address the corresponding expectations of involved pharmacists, the packaging and labeling of medication for a specific patient by an automated device at a specialized prescription drug outlet. The purpose of the proposed amendments to Board Rule 25.00.16 is to require annual inventories of controlled substances in specialized prescription drug outlets.
