### FINAL REGULATIONS - CHAPTER W-9 - WILDLIFE PROPERTIES

#### **ARTICLE I - GENERAL PROVISIONS**

# #900 - REGULATIONS APPLICABLE TO ALL WILDLIFE PROPERTIES, EXCEPT STATE TRUST LANDS

### A. DEFINITIONS

- "Aircraft" means any machine or device capable of atmospheric flight, including, but not limited to, airplanes, helicopters, gliders, dirigibles, hot air balloons, rockets, hang gliders and parachutes, parasails, kite boards, kite tubes, wingsuits, zip lines and other similar devices or equipment and any models thereof.
- 2. "Camping" means the erecting of a tent or shelter of natural or manmade material, the placing of a sleeping bag or other bedding material on the ground, the parking of a motor vehicle, motor home, travel trailer or other similar equipment for the apparent purpose of overnight occupancy.
- 3. "Camping Unit" is defined as one of the following:
  - a. Two tents and a passenger vehicle; or
  - b. One tent plus one motorhome (Class A, B, C), motor vehicle, vehicle, trailer, slide-in truck camper, pop-up camper/trailer, boat, or other equipment of any description manufactured and/or used for the purposes of overnight occupancy;
  - c. A camping unit may include additional tents only in a campsite with a tent pad;
     provided the tents are contained on the pad and other camping unit and camping group limits are observed; or
    - d. One passenger vehicle in addition to the above descriptions is authorized only if available parking space exists.
- 4. "Vessel" means every description of watercraft used or capable of being used as a means of transportation of persons and/or property on water. This includes but is not limited to single and multi-chambered stand-up paddleboards, float tubes, and tubes.
- 2.5. "Water contact activities" means swimming, wading (except for the purpose of fishing or hunting), waterskiing, surfing, sail-surfboarding, scuba diving, and other water-related activities which put a person in contact with the water (without regard to the clothing or equipment-worn or equipment wornused).
- 3.6. "Youth mentor hunting" means hunting by youths under 18 years of age. Youth hunters under 16 years of age shall at all times be accompanied by a mentor when hunting on youth mentor properties. A mentor must be 18 years of age or older and hold a valid hunter education certificate or be born before January 1, 1949.

### B. Public Access to State Wildlife Areas

- 1. Only properties listed in this chapter are open for public access.
- 4.2. The Director may open newly acquired properties for public access for a period not to exceed nine (9) months pending adoption of permanent regulations. In addition, the Director may establish and post restrictions based upon consideration of the following criteria:
  - a. The location and size of the area.
  - b. The location, type and condition of roads, vehicle parking areas and the number and type of sanitary facilities available.
  - c. The number of users and vehicles the area will tolerate without significant degradation to wildlife resources, and public or private property.
  - d. Opportunity to assure public safety, health and welfare.
- 2.3. If a property is opened for public access pursuant to this provision, the property shall be posted with a list of applicable access restrictions. It shall be unlawful for any person or vehicle to enter any such property, except in accordance with its posting and the applicable restrictions.

### C. Prohibited Activities

Except as otherwise provided inspecifically authorized in 901.B of these regulations or specifically authorized by contractual agreement, official document, public notice, permit, or posted sign, the following activities are prohibited on all lands, waters, the frozen surface of waters, rights-of-way, buildings, and other structures or devices owned, operated, or under the administrative control of Colorado Parks and Wildlife:

- 1. To enter, use or occupy any State Wildlife Area or portion thereof for all persons 16 years of age and older without:
  - a. a hunting license valid for the current license year,
  - b. a valid fishing license, or
  - c. a valid Colorado State Wildlife Area pass.

Annual hunting licenses, including all big game hunting licenses, small game hunting licenses, turkey hunting licenses, annual fishing licenses, and annual Colorado State Wildlife Area passes are only valid for the individual specified on the license or pass, and authorize such individual to enter, use or occupy any State Wildlife Area or portion thereof from March 1 through March 31 of the following year, also known as the current license year. Daily Colorado State Wildlife Area passes and daily or multi-day fishing and small game licenses are only valid for the individual specified on the license or pass, and authorize such individual to enter, use or occupy any State Wildlife Area or portion thereof only on the date(s) indicated on the license or pass.

- 2. To enter, use, or occupy any area or portion thereof for any purpose when posted against such entry, use, or occupancy.
- 3. To enter, use, or occupy any area for any commercial purpose or to conduct land, water, oil, gas, or mineral investigations, surveys, or explorations of any kind.

- 4. To operate any form of vehicle, or bicycle (motorized or non-motorized) except on established roads open to public motor vehicle use or within designated camping or parking areas. All motor vehicles and the operators thereof must be in compliance comply with all Colorado statutes and regulations pertaining to motor vehicle operation. This regulation does not prohibit the use of non-motorized game carts.
- 5. To operate a <u>any</u> motor vehicle, <u>snowmobile</u>, <u>off highway vehicle or bicycle</u> in excess of posted speed limits or in excess of 25 miles per hour where not posted.
- 6. To camp recreationally. To use or occupy a state wildlife area as a residence. Where camping is specifically authorized tTo leave a camp, pitched tent, shelter, motor vehicle, or trailer unattended for more than 48 hours, or to camp or to park a travel trailer or camper on any one state wildlife area for more than 14 days in any 45-day period.
- 7. To build, erect, or establish any permanent structure or to plant any vegetation. Only portable blinds or treestands and steps may be erected by the public on state wildlife areas. No nails may be driven into trees. Portable blinds or tree stands intended for use to hunt any big game or waterfowl during an established season may be erected on state wildlife areas no earlier than 30 days prior to the season in which they are used. All man-made materials used for blinds or tree stands during big game or waterfowl seasons must be removed within 10 days after the end of the season in which they are used. Any other portable blind or tree stand used for any other purpose must be removed at the end of the day in which they are used. The Customer Identification Number of the owner and the date(s) to be used must be displayed on the outside of all portable blinds and on the underside of all tree stands in a readily visible area. However, the erection or placement of any blind or tree stand by any person does not reserve the blind or tree stand for personal use. All such blinds and tree stands remain available for use to the general public on a first come, first-served basis.
- 8. To remove, modify, adjust, deface, destroy, or mutilate any building, structure, water control device, fence, gate, poster, notice, sign, survey or section marker, tree, shrub or other vegetation or any object of archaeological, geological, or historical value or interest.
- To place fixed or permanent rock climbing hardware, unless the climber first obtains written permission from the Area Wildlife Manager pursuant to regulation #900.H. Removal of previously placed fixed or permanent climbing hardware is prohibited.
- 8-10. To litter in any form, to leave fish, fish entrails, human excrement, waste water, containers or cartons, boxes or other trash, garbage or toxic substance on any area or to bring any household or commercial trash, garbage or toxic substance to a Division-controlled area for disposal, or to dump trailer waste into any toilet or sanitary facility.
- 9.11. To set, or build, or tend a fire-without provision to prevent the spreading thereof, or to leave a fire unattended. Where fires are specifically authorized, to allow a fire to burn in a careless manner; to leave any fire unattended; or to fail to completely extinguish any fire.

- 40.12. To release or allow livestock to graze or range on any area, except that horses, mules, llamas, and burros may be used when in direct association with wildlife recreational activities.
- 44.13. To possess, use or apply explosives (other than lawful firearm ammunition), fireworks, poisons, herbicides, insecticides or other pesticides.
- 14. To release wildlife or privately-owned game birds, except privately-owned game birds released for field trials, including group dog training, or on those state wildlife areas where release for dog training is specifically authorized. in #901.B of these regulations; or
- 42.15. <u>tTo allowto permit dogs</u>, cats, or other domestic pets to run at large (not on a leash) on any area, except dogs lawfully used while actively hunting, or while training dogs for hunting, or during Division licensed field trials. <u>Service animals</u>, as defined by 28 C.F.R. § 35.104(2016) are permitted. Later amendments to the definition of service animal are not incorporated. Copies of the definition may be obtained at Colorado Parks and Wildlife, 6060 Broadway, Denver CO 80216 or via the U.S. Department of Justice, Civil Rights Division, Disability Rights Section, 950 Pennsylvania Avenue, NW, Washington, D.C. 20530-0001.
- 13.16. To excavate or dig trenches, holes, or pits.
- 14.17. To launch, or take out vessels, except those being actively used for fishing and/or hunting. To leave vessels beached, at anchor, moored or docked unattended overnight, except in areas designated for that purpose.
- <u>15.18.</u> To fish from, block or impede any Division-controlled boat ramps or boat docks when in conflict with boaters or as posted.
- 46.19. To snorkel, scuba dive, or spearfish with the aid of diving mask, swim fins, snorkel, and/or air tanks, except in waters where swimming is permitted, when location is properly identified by a "divers down flag," and when the scuba diver has a valid S.C.U.B.A. diver's certificate issued by a recognized S.C.U.B.A. training organization.
- 17.20. To engage in any unlawful conduct or act as defined in Title 18, C.R.S.
- 18. To utilize any air or gas inflated floating device as a means of transportation upon or across the surface of the water unless such device is of multi-compartment construction and has a rigid motor mount for those devices propelled by gasoline or electric motors. Single compartment air or gas filled flotation devices are restricted to designated swimming areas.
  - 49.21. To promote, sponsor, er-conduct or participate in boat regattas, paintball shooting, questing, or other non-wildlife oriented activities.
  - 20.22. To launch or land any aircraft.
  - 23. To launch, land or operate any unmanned aerial vehicle including but not limited to drones, and model airplanes.

- 21.24. To leave any decoys or anything used as decoys set up in the field or on the water overnight.
- 22.25. To engage in water contact activity, To swim, except in designated waters or where in association with specifically authorized water contact activities.
- 23.26. To discharge a firearm or bow within designated parking, camping, or picnic areas.
- 24.27. To possess the following types of ammunition and/or firearms: tracer rounds, armorpiercing rounds, military hardened rounds with explosive or radioactive substances, .50 caliber BMG rounds, or fully automatic firearms.
- 25-28. To possess, store, or use hay, straw, or mulch which has not been certified as noxious weed free in accordance with the Weed Free Forage Crop Certification Act, Sections 35-27.5-101 to 108, C.R.S., or any other state or province participating in the Regional Certified Weed Free Forage Program. See Appendix A of this chapter. All materials so certified shall be clearly marked as such by the certifying state or province. Exempted from this prohibition are persons transporting such materials on Federal, State, or County roads that cross Division property; and hay produced on the property where it is being used.
- 26.29. Upon notification by authorized Colorado Parks and Wildlife personnel of a violation of any of the above (or any other law of the State of Colorado) and where the unlawful activity is not immediately and permanently discontinued or if it is of a continuing nature, the violator(s) may be required to leave Colorado Parks and Wildlife property for a minimum of 72 hours.
- 27.30. To trap, unless such trapping is done in accordance with the provisions of 33-6-204 (General Exemptions), 33-6-205 (Exemptions for Departments of Health), 33-6-206 (Nonlethal Methods Exemptions), #901 and Chapter W-3 of these regulations. Persons wishing to use the above-mentioned exemptions must have prior authorization from Colorado Parks and Wildlife.
- 28.31. To conduct field trials or group dog training without first obtaining a field trial license, in accordance with the provisions of Chapter W-8 of these regulations.
- 29.32. 30. Consumption of alcoholic beverages on lands and waters under the supervision, administration, and/or jurisdiction of the Division is permitted with the following exceptions:
  - a. It shall be prohibited to consume alcoholic beverages on any archery or firearm range unless specifically authorized by a concession contract, cooperative agreement or special activities permit, and then only allowed in areas specifically designated by the contract, agreement, or permit.
  - b. It shall be prohibited to sell and/or dispense alcoholic beverages on any lands and waters under the supervision, administration, and/or jurisdiction of the Division unless specifically authorized by a concession contract, cooperative agreement, or special activities permit, and then only allowed in areas specifically designated by the contract, agreement, or permit and the applicant party has obtained all appropriate licenses and permits to sell and/or dispense alcoholic beverages.

c. It shall be prohibited to be present on any lands and waters under the supervision, administration, and/or jurisdiction of the Division when under the influence of alcohol or any controlled substance to the degree that may endanger oneself or another person, damage property or resources, or may cause unreasonable interference with another person's enjoyment of any lands or waters under the supervision, administration, and/or jurisdiction of the Division.

## D. Limitation of People and Vehicle Usage

 The Director of Colorado Parks and Wildlife may establish and enforce a limitation not to exceed sixty (60) days, on public occupancy of the land and water areas owned or leased by the Division.

The Director shall use only the following criteria when establishing such limitation:

- a. The location and size of the area.
- b. The location, type and condition of roads, vehicle parking areas and the number and type of sanitary facilities available.
- c. The number of users and vehicles the area will tolerate without significant degradation to wildlife resources, and public or private property.
- d. Opportunity to assure public safety, health and welfare.
- 2. Whenever such limitation is exercised, the area(s) involved shall be posted indicating the specific number of persons or vehicles permitted within the area at all times when such area is posted. It shall be unlawful for any person or vehicle to enter any such area(s) posted as being fully occupied or after being advised by an officer of the Division that the area is full.
- 3. The Division may waive these restrictions for daytime use during a specified period of time for organized supervised groups whose numbers exceed the limitations set forth. Written approval must first be obtained from the appropriate Regional Manager.

### E. Closure of Properties to Public Use

- 1. The Director of Colorado Parks and Wildlife may establish and enforce temporary closures of, or restrictions on, lands or waters owned or leased by the Division, or portions thereof, for a period not to exceed nine months, when any one of the following criteria apply:
  - a. The property has sustained a natural or man-made disaster such as drought, wildfire, flooding, or disease outbreak which makes public access unsafe, or where access by the public could result in additional and significant environmental damage.
  - b. The facilities on the property are unsafe.
  - c. To protect threatened or endangered wildlife species, protect wildlife resources from significant natural or manmade threats, such as the introduction or spread of disease or nuisance species, changing environmental conditions or other similar threats, protect time-sensitive wildlife use of lands or waters, or facilitate Division-sponsored wildlife research projects or management activities.

- 2. Whenever such closure is instituted, the area(s) involved shall be posted indicating the nature and purpose of the closure. It shall be unlawful for any person or vehicle to enter any such area(s) posted as closed.
- F. Criteria for Activities Requiring Express Authorization Whenever an activity requires expressed authorization (e.g. target practice) the Division shall grant or deny permission based on consideration of public safety and wildlife resource protection.

### G. Commercial Use of State Wildlife Areas

- Except as provided herein, commercial use of state wildlife areas, including, but not limited to, the provision of any goods or services to members of the general public using the state wildlife area, is prohibited. However, commercial uses of state wildlife areas may be allowed by the Division when:
  - a. such commercial use will not adversely impact wildlife resources or habitat;
  - b. there is a demonstrated need for the goods or services to be provided as part of such commercial use:
  - c. such commercial use will not unreasonably interfere with the primary wildlife related recreational uses of the state wildlife area by members of the general public;
  - d. the state wildlife area, and its existing facilities, can safely accommodate such commercial use; and
  - e. Such commercial uses may be exclusive or nonexclusive, as determined by the Division to be necessary for the proper management of the state wildlife area in light of the criteria set forth above and the compensation provided to the Division.
- 2. Prior to making any commercial use of a state wildlife area, a person must receive a permit from the Division or enter into a commercial use agreement with the Division providing for such use. Any person accessing a State Wildlife Area under such authority is not required to have a valid hunting or fishing license, or Colorado State Wildlife Area pass. Such permit or agreement shall, at a minimum, include provisions regarding:
  - a. the specific goods or services to be provided;
  - b. user number restrictions;
  - c. seasonal or time restrictions;
  - d. record-keeping requirements, including, but not limited to, a requirement that the authorized user maintain records regarding the goods and services provided, the date(s) and time(s) the person provided these goods and services on the property, and the number of goods or services provided, by user day, for a period of at least three years. Such records shall be available for inspection by the Division;
  - e. compensation to the Division: a minimum fee equal to 5% of the gross income generated by the activity shall be paid to the Division, but in no event shall any fee for a commercial use permit or agreement be less than \$100. The \$100 minimum shall be paid at the time the permit is issued or the agreement is signed. The Division may impose additional items, conditions and charges in connection with the permit or agreement as reasonably necessary to offset the administrative burden, costs or risks associated with the proposed activities;
  - f. the Division may retain third party consultants to evaluate the potential adverse impacts of the proposed activity and develop appropriate strategies to offset or mitigate such risks. The applicant shall be notified if the Division decides to retain a consultant and shall be given the opportunity to provide input concerning consultant

- selection and scope of work. The applicant shall be responsible for the actual costs associated with this consultant review.
- g. the term or length of the permit or agreement, and a provision providing for cancellation or termination of such permit or agreement for any failure to comply with its terms and conditions and any applicable laws;
- h. any other provision necessary to protect wildlife resources, habitat or public safety, to prevent conflict with primary wildlife related recreational uses of the state wildlife area by the general public or to properly administer the commercial use and the commercial use permit or agreement, including bonding requirements.
- 3. Incidental commercial services such as the renting of pack animals or their services to remove harvested animals; emergency vehicle repairs or tow services; or other similar incidental services may be provided to wildlife recreational users without a commercial use permit or agreement when the service is relatively infrequent, the provider does not advertise for or solicit business specifically for a state wildlife area and maintains a separate place of business, and the service is not one for which the provider is required by law to obtain a guide or outfitter license.

### H. Special (Non-Wildlife Related) Use of State Wildlife Areas

- 1. Except for uses or activities otherwise specifically prohibited by these regulations, the Division may allow special (non-wildlife related) uses of state wildlife areas. Special uses may only be allowed if:
  - a. such use will not adversely impact wildlife resources or habitat;
  - b. such use will not interfere with wildlife-related recreational uses of the state wildlife area by members of the general public;
  - c. such use is non-commercial in nature; and
  - d. the state wildlife areas, and its existing facilities, can safely accommodate such use.
- 2. Prior to making any special use of a state wildlife area, a person must receive a permit from the Division or enter into a special use agreement with the Division. Any person accessing a State Wildlife Area under such authority is not required to have a valid hunting or fishing license, or Colorado State Wildlife Area pass. Such permit or agreement shall, at a minimum, include provisions regarding:
  - a. the nature of the special use;
  - b. user number restrictions;
  - c. time and date restrictions;
  - d. compensation to the Division: A minimum fee of \$100 shall apply to all special use permits and agreements, but in no event shall the compensation received by the Division be less than the costs of administering such use, including, but not limited to, staff time:
  - e. cancellation or termination of the permit or agreement for any failure to comply with the terms and conditions of the permit or agreement and any applicable laws; and
  - f. any other provision necessary to protect wildlife resources, habitat or public safety, to prevent conflict with primary wildlife related recreational uses of the state wildlife area by the general public or to properly administer the special use and the special use permit or agreement, including bonding requirements.

### I. Utility and Road Easements

- 1. The Director may grant easements, for a term not to exceed twenty-five (25) years, on properties owned in fee title by the Division after consideration of the following:
  - a. financial consideration for the easement represents fair market value and is no more than \$100,000;
  - b. the easement is customary or minor in nature, or is a replacement, modification or confirmation of an existing easement;
  - the easement is not detrimental to wildlife habitat, water resources, or the operation
    of a hatchery, fish rearing facility or administrative facility and is in the public interest;
    and
  - d. the businesses or persons involved in or maintaining the utility or road easements are not required to have a valid hunting or fishing license, or Colorado State Wildlife Area pass.

### J. Leases

- 1. The Director may execute documents related to existing leases wherein the Division is either the lessor or lessee, after consideration of the following:
  - a. the document is a renewal, extension or amendment of an existing lease;
  - b. the renewal or extension is for a term not to exceed twenty-five (25) years;
  - c. total consideration for the entire potential term of the renewal, extension or amendment represents fair market value and is no more than \$100,000;
  - d. the renewal, extension or amendment supports, protects, enhances or is not detrimental to wildlife habitat, water resources or the operation of a hatchery, fish rearing facility or administrative facility and is in the public interest; and
  - e. the businesses or persons involved in or maintaining the lease are not required to have a valid hunting or fishing license, or Colorado State Wildlife Area pass.

2. The Director may execute a new lease for staff housing for a term not to exceed twelve (12) months.

#### ARTICLE II - PROPERTY-SPECIFIC PROVISIONS

### **#901 - PROPERTY-SPECIFIC REGULATIONS**

See Appendix B for a list of properties without property-specific regulations, to which only restrictions in #900 apply)

- A. On all Division properties which have reservations available or required, those reservations may be made by phone or online (cpw.state.co.us). Reservations for small game and waterfowl hunting may not be made more than 14 days in advance of the hunt date, nor after 12:00 noon on the day before the hunt date. Reservations for big game hunting may not be made more than 45 days in advance of the start of the season for which the reservation is being made. Unless otherwise specified, reservations for big game hunting are valid throughout the season designated by the license. Hunters who wish to cancel a reservation must do so no later than 12:00 noon on the day before the hunt date. Failure to hunt a reserved area without prior cancellation, or follow check station procedures, may cause forfeiture of the privilege to make reservations for the remainder of the hunting season. Hunters are limited to a maximum of one reservation per hunt date. Hunters must possess a valid license for the species to be hunted in order to make a reservation. Reservations are not transferable. The individual named on the reservation must be at the property on the day of the hunt. Hunters with reservations may only hunt the hunt area specified on the reservation. Any exceptions to the above restrictions will be listed under property specific regulations.
- **B.** In addition to or in place of those restrictions listed in regulation #900, the following provisions or restrictions apply:

### 1. Adams State Wildlife Area - Routt County

- a. Public access is prohibited from December 1 through June 30July 15.
- b. <u>Discharge of firearms or bows is prohibited, except while hunting. Camping is prohibited.</u>
- c. Fires are prohibited.
- d. Dogs are prohibited, except as an aid in hunting grouse.
- e. Vehicle access is prohibited beyond the parking area.

## 2. Adobe Creek Reservoir State Wildlife Area - Bent and Kiowa Counties

- a. Public access is prohibited from one (1) hour after sunset to one (1) hour before sunrise daily, except while for camping, while hunting, or while fishing.
- b. All terrain vehicles, dirt bikes, and snowmobiles are prohibited.
- e. Public access to the frozen surface of the lake is prohibited.
- ec. Public access to the dams, inlets, and outlet structures is prohibited, except for while fishing.
- d. Launching and use of all vessels is allowed.
- e. Water contact activities are allowed.
- f. Camping is allowed in designated and established camping areas only.

g. Fires are allowed within an established containment structure in designated areas.

## 3. Alberta Park Reservoir State Wildlife Area - Mineral County

- a. Launching and use of all vessels is allowed.
- b. Operating a vessel in a manner that creates a whitewater wake is prohibited.

## 3.4. Almont Triangle State Wildlife Area - Gunnison County

a. Public access is prohibited from December 1 through April 30.

### 5. Andrews Lake State Wildlife Areas - San Juan

a. Vessel use is prohibited, except for hand-launched vessels that are propelled by hand.

## 4.6. Andrick Ponds State Wildlife Area - Morgan County

- a. Public access is prohibited from 9:00 p.m. 4:00 a.m.
- b. Public access is limited to Saturdays, Sundays, Wednesdays, and state and federal holidays.
- c. Camping is prohibited From June 1 through August 31 wildlife viewing is allowed from designated area only.
- d. From September 1 through the dark goose season, only migratory bird hunting within designated areas is permitted. Reservations are required and valid until sunrise, and are limited to three (3) per hunter annually. Reservations must be made in accordance with #901.A of these regulations. Fires are prohibited.
- e. Hunters must check-in and out at check stations. Hunters may not check-in until 4:00 a.m. and can only hunt the area reserved. Hunters may check-in on a first-come, first-serve basis after a hunter checks out or after sunrise if a hunter has not checked-in. Maximum of four (4) hunters allowed per hunting area. Fishing is prohibited.
- f. From the end of the dark goose season through the spring turkey season, only turkey hunting is permitted. During spring turkey season, reservations are required and valid until sunrise. Hunters must check-in and out at the check station on CR AA, but may hunt the entire property. Dog training is prohibited.
- g. During waterfowl and turkey seasons, scouting is prohibited, except on Thursdays from 10:00 a.m. 2:00 p.m. All persons must check-in and out at check stations. All firearms and dogs are prohibited while scouting. Target practice is prohibited.
- h. Hunting with centerfire rifles is prohibited.
- i. Hunting on Clark Lake is prohibited.
- j. From September 1 through the dark goose season, only migratory bird hunting within designated areas is permitted. Reservations are required and valid until sunrise, and are limited to three (3) per hunter annually. Reservations must be made in accordance with #901.A of these regulations. Discharge of firearms or bows is prohibited, except while hunting.
- k. Hunters must check-in and out at check stations. Hunters may not check in until 4:00 am and can only hunt the area reserved. Hunters may check-in on a first-come, first-serve basis after a hunter checks out or after sunrise if a hunter has not checked-in. Maximum of four (4) hunters allowed per hunting area. Fishing is prohibited.

- I. From the end of the dark goose season through the spring turkey season, only turkey hunting is permitted. During spring turkey season, reservations are required and valid until sunrise. Hunters must check-in and out at the check station on CR AA, but may hunt the entire property. Dogs are allowed but must be kept under control on a physical leash by the handler at all times.
- m. During waterfowl and turkey seasons, scouting is prohibited, except on Thursdays from 10:00 am 2:00 pm. All persons must check in and out at check stations. All firearms and dogs are prohibited while scouting. Dog training is prohibited.

## 7. Apishapa State Wildlife - Las Animas County

- a. Public access is prohibited from June 1 through August 15.
- b. Camping is allowed in designated parking areas by licensed hunters during an established big game, spring turkey, and fall turkey season plus three (3) days before and three (3) days after each season.

# 5. Arikaree State Wildlife Area - Yuma County

## 8-11. Banner Lakes State Wildlife Area - Weld County

Reservations may be made in accordance with #901.A of these regulations. No more than four hunters are allowed per reservation. Hunters with reservations may only hunt the hunt area specified on the reservation. Discharge of firearms or bows is prohibited, except when hunting or training hunting dogs.
- e. <u>Waterfowl hunters must check-in and check out at the designated check</u> station. <u>Discharge of bows is allowed for bowfishing.</u>
- f. Horseback riding is prohibited Discharge of firearms or bows is prohibited, except while hunting, training hunting dogs, or bowfishing.
- g. Bicycling is prohibited.
- h.—Fishing is prohibited from October 1 through the end of February.
- ih. Public access is prohibited from the first day of the regular waterfowl season to the day before the first day of pheasant season, except for waterfowl hunting on Saturdays, Sundays, Mondays and state and federal holidays. During this period reservations are available for waterfowl, but not required. Reservations are valid throughout the reserved day until the hunter with the reservation checks out. Hunters may check in on a first come, first served basis after a hunter with a reservation checks out, or if no reservation exists for a hunt area after 12:00 midnight immediately preceding the hunt, or if a reserved area is not claimed by legal sunrise. Reservations may be made in accordance with #901.A of these regulations. No more than four hunters are allowed per reservation. Hunters with reservations may only hunt the hunt area specified on the reservation.Vessel use is prohibited, except for hand-launched vessels that are propelled by hand when used as an aid for fishing or hunting or dog training.
- ij. From the Thursday before September 1 through the end of the dark goose season, scouting is permitted only on Thursdays that are not open to hunting within and immediately prior to established waterfowl seasons. Scouting will be permitted from 10:00 am until 2:00 pm with a reservation confirmation number or letter issued by the Division, and all persons scouting must check in and check

- out at the check station. During scouting dates, firearms and dogs are prohibited. Horse use is prohibited.
- kj. Waterfowl hunters must check in and check out at the designated check station. Bicycles are prohibited.
- Ik. Public access is allowed only through designated parking areas.
- m. Public access is prohibited north of Colo 52 from April 1 through July 15.
- n. Public access is restricted to foot traffic only.
- Dog training is <u>permitted allowed</u> north of Colo 52 during February, March and July 16 to August 31 only. -Dog training is <u>permitted allowed</u> south of Colo 52 from February 1 through August 31 only.
- pl. Field trials may be authorized during February, March, and August only. -No more than four (4) field trials will be allowed per year, except that the number of group training events will not be limited.
- qm. Domestic birds, feral birds, or privately-ownedprivately owned game birds may be released for field trials and for dog training south of Colo 52 by permit only, in accordance with the provisions of this chapter and other applicable regulations, including, but not limited to, #007, #008, #009, #801 and #804 of these regulations. All such birds taken during training activities shall be removed from the State Wildlife Area by the dog training permittee and all privately-owned game birds shall be prepared for human consumption.
- **Fn**. The Division is authorized to implement a dog training reservation system should overcrowding become an issue on the State Wildlife Area.

# 9-12. Basalt State Wildlife Area (Basalt Unit, Christine Unit, Toner Unit, Peachblow Unit, 7 Castles Unit, Schuck Unit) - Eagle and Pitkin Counties

Discharge of shotguns is allowed.
- b. With the exception of Christine Lake and the Basalt Shooting Range, public access is prohibited from December 1 through July 15, except while spring turkey hunting. Fully automatic firearms are prohibited.
- c. Discharge of firearms or bows is prohibited, except while hunting or on the designated shooting range. From March 15 October 14, firearms may only be discharged on the shooting range on Monday, Tuesday, Thursday and Friday from 7:00 a.m. until 7:00 p.m., and on Saturday and Sunday from 9:00 a.m. until 5:00 p.m. From October 15 March 14, firearms may only be discharged on the shooting range on Monday, Tuesday, Thursday and Friday from 9:00 a.m. until 4:00 p.m., and on Saturday and Sunday from 9:00 a.m. until 4:00 p.m.
- d. Boating is Vessel use is prohibited on Christine Lake.
- e. Camping is prohibited allowed, except by licensed hunters during an established big game or turkey season plus three (3) days before and three (3) days after each such season. With the exception of the Christine Lake and rifle range areas, all human activity is prohibited from December 1 to April 15 of the following year.

- f. Camping is prohibited at all times within one-quarter (1/4) mile of the Frying Pan River.
- g. Fires are prohibited.
- h. Water contact activities are prohibited on Christine Lake.
- i. Field trials may be authorized during August and September only.
- i. Dogs are prohibited, except as provided in 'i'.
- k. Mountain bikes are prohibited.

## 10.13. Bayfield Lions Club Shooting Range - La Plata County

- a. Public access is allowed April 1 through November 30.

Applications to enter the drawing are available at the CPW Brush Service Center in mid-August. Hunters must possess a valid license to hunt waterfowl to enter the drawing. All such birds taken during training activities shall be removed from the State Wildlife Area by the dog training permitee and all privately-owned game birds shall be prepared for human consumption. Target practice is prohibited, except when authorized by the area wildlife manager.
- ke. Big game hunting on all units is restricted to the use of archery, shotguns with slugs, and muzzle-loading only. Vessel use is prohibited, except for launching and use of vessels that are propelled by hand and used for waterfowl hunting, dog training or field trials.
- fl. Field trials may be authorized on the Wellington and Schware units during February, March 1 through 14, and August only. Field trials may be authorized on the Cobb Lake Unit year-round.
- g. Game birds listed in #009(B) of these regulations may be released on the Cobb Lake Unit by the Division or its agent for educational or training purposes without seasonal or numerical restrictions.
- h. Domestic birds, feral birds, or privately-owned game birds may be released year-round for dog training on the Cobb Lake Unit by permit only, in accordance with the provisions of this chapter and other applicable regulations, including, but not limited to, #007, #008, #009, #801 and #804 of these regulations. All such birds taken during training activities shall be removed from the State Wildlife Area by the dog training permittee and all privately-owned game birds shall be prepared for human consumption.
- i. Horse use is prohibited, except at the Cobb Lake Unit, where horses may be used during field trials.
- j. The Division is authorized to implement a dog training reservation system should overcrowding become an issue on the State Wildlife Area.

## **264.277.** West Lake State Wildlife Area - Larimer County

a. Boating Vessel use is prohibited, except for launching and use of vessels that are float tubes or craft propelled by hand, wind or electric motor.

b. Public access to West Lake State Wildlife Area is exempt from requirements set forth in section #900(C)1 of these regulations.

## 265.278. West Rifle Creek State Wildlife Area - Garfield County

- a. <u>Public access is prohibited on the designated shooting range between sunset</u>
  <u>and sunrise. Camping is prohibited, except from the day after Labor Day through December 31.</u>
- b. <u>Discharge of firearms or bows is prohibited, except while hunting or on the designated shooting range.</u> Public access is prohibited on the West Rifle Creek Shooting Range, except between sunrise and sunset daily when in compliance with all posted range rules.
- c. Camping is allowed by licensed hunters during an established big game season plus three (3) days before and three (3) days after each season.
- d. Fires are allowed within a containment structure while camping.

## 266-279. Whitehorse State Wildlife Area - Adams County

- a. Public access is <u>limited to prohibited</u>, except for youth <u>and mentors who have</u> received certification to use the property as participants in the youth hunting <u>program.waterfowl hunting only</u>, when authorized by the Area Wildlife Manager as participants in the Division's youth hunting program.
- b. Public access is limited to dates specified by the program.
- c. Parking and access is allowed from designated parking areas only.
- d. A reservation is required for all waterfowl hunting. Reservations are available to authorized participants for waterfowl hunting. Reservations may be mademust be made in accordance with #901.A of these regulations. -Hunters with reservations may only hunt the hunt-area specified on the reservation, except when hunting areas where reservations are not required or on hunt areas which are unreserved and unoccupied. Hunters must follow check in and check out procedures as posted.
- <u>ee</u>. Waterfowl hunters must check-in and check-out at the designated check station and the reservation holder must be present while hunting.

#### 267,280. Williams Creek Reservoir State Wildlife Area - Hinsdale County

- a. Launching and use of all vessels is allowed. Camping is prohibited.
- b. Operating a vessel in a manner that creates a whitewater wake is prohibited. Fires are prohibited.
- c. <u>Discharge of firearms or bows is prohibited, except while hunting.</u> <del>Boating in a manner that creates a white water wake is prohibited.</del>
- d. Snowmobiles are allowed only as an aid in ice fishing.
- e. Dogs are allowed but must be kept under control on a physical leash by the handler at all times, except as authorized in #900(C)(15). Sail surfboards are prohibited.

#### 268-281. Willow Creek State Wildlife Area (Fishing and Hunting Lease) - Yuma County

- a. Public access is prohibited from June 1 through August 31.
- b. Public access is prohibited from 9:00 p.m. 4:00 a.m.
- c. Camping is prohibited.
- d. Fires are prohibited.
- e. Dog training is prohibited.

- fd. Horses use is are prohibited.
- g. Target practice is prohibited except when authorized by the area wildlife manager.

# 269. 282. Willow Creek Reservoir State Wildlife Area (Fishing/Hunting Lease) - Grand County

- a. <u>Public Aa</u>ccess <u>is prohibited, exceptpermitted whilefor</u> fishing, small game, and waterfowl hunting <u>enly</u>.
- b. <u>Public aAccess permitted is allowed only through designated access points as posted.</u>
- c. Hunting with centerfire rifles prohibited.
- d. Camping is prohibited.
- e. Fires are prohibited.

## 270-283. Wind in the Willows State Wildlife Area - Hinsdale County

- b.e. Fishing access is allowed only on the Lake Fork of the Gunnison River, including twenty (20) feet on either side of the riverbank.
- c. Public access is prohibited from one (1) hour after sunset to one (1) hour before sunrise.

- e.f. Dogs and other pets are prohibited.
- f. Camping is prohibited.
- g. Fires are prohibited.

## 271.284. Windy Gap Watchable Wildlife Area - Grand County

- a. <u>Public access is prohibited outside of the viewing area.</u> Dogs are prohibited beyond the parking area.
- b. Public access is prohibited from sunset to sunrise. Fishing is prohibited.
- c. Discharge of firearms or bows is prohibited.
- d. <u>Hunting is prohibited.</u> Camping is prohibited.
- e. Fires are Fishing is prohibited.
- f. Dogs are allowed but must be kept under control on a physical leash by the handler at all times No human activity allowed outside viewing area.
- g. Public access is prohibited from sunset to sunrise.

#### 272.285. Woods Lake State Wildlife Area - San Miguel County

- a. Boating Vessel use is prohibited, except for launching and use of vessels that arefloat tubes or craft propelled by hand, wind or electric motor.
- b. Camping is prohibited. Dogs are allowed but must be kept under control on a physical leash by the handler at all times, except as authorized in #900(C)(15).

## 273.286. Yampa River State Wildlife Area - Routt County

- a. a. Discharge of firearms or bows is prohibited, except while hunting.
- a. Launch or take out of vessels, except those being actively used for fishing, hunting or wildlife viewing is prohibited. Camping is prohibited.
- b. b. Fires are prohibited.

# 274.287. Yarmony Ranch State Wildlife Area (Hunting and Fishing Easement) - Jackson County

- a. Public access is prohibited, except while hunting or fishing.
- b. Hunting is allowed for elk, moose and pronghorn with a limited public access permit onlyrestricted to antelope, moose and elk.
- <u>bc.</u> <u>Limited public access permits may be obtained by contacting the CPW Steamboat Springs Service Center at 970-870-3333. Fishing is by artificial flies and lures only. The possession limit is two fish.</u>
- ed. To obtain a limited public access permit, hunters must already possess a big game license for one of the specific hunt codes permitted on the property. Limited access permits for big game hunting may be obtained by contacting the CPW Steamboat Springs Service Center at 970-870-2197.
- de. Limited access permits will be valid starting the 1st day of the season of the license. Hunters may only access the property during the dates specified on their limited access permit.
- ef. Hunters may only access the property during the dates specified on their limited public access permit and may be accompanied by up to two (2) people who are not hunting. To obtain a limited access permit, hunters must already possess a big game license for one of the specific hunt codes permitted on the property.
- fg. Public access by hunters with a limited public access permit is prohibited prior to two (2) hours before sunrise and after one (1) hour following sunset, except that when an animal has been harvested, the successful hunter and their non-hunter companion shall be allowed to remain as long as necessary to remove it. Limited access permits will be valid starting the 1<sup>st</sup> day of the season of the license.
- gh. Fishing is prohibited during established big game hunting seasons.
- i. Parking and public access is allowed from designated parking areas only. Access by hunters with a limited access permit is prohibited prior to two hours before sunrise and after one hour following sunset, except that when an animal has been harvested, the successful hunter and his/her non-hunter companion shall be allowed to remain as long as necessary to remove it. The person who is not hunting must possess a valid hunting or fishing license or Colorado State Wildlife Area pass if 16 years or age and older.
- hj. Public access is allowed by foot and horseback only. Hunting is not allowed in the safety zone.
- ik. Access is only permitted from designated parking areas Discharge of firearms or bows is prohibited in the designated safety zones, or as posted.

- <u>jl</u>. Access is permitted by foot and horseback only Discharge of firearms or bows is prohibited, except while hunting.
- mk. Hunters with a limited access permit may be accompanied by up to two (2) people who are not huntingBuilding blinds is prohibited.
- I. The following are not permitted on the property: overnight camping, dogs, fires, target shooting, and building blinds.

#### **ARTICLE IV - STATE FISH UNITS**

#### **#905 - PROPERTY SPECIFIC REGULATIONS**

## E. Roaring Judy State Fish Unit - Gunnison County

- 1. Public access is prohibited from <u>one (1)</u> hour after sunset to <u>one (1)</u> hour before sunrise.
- 2. Public access is prohibited from December 1 through April 30 on that portion of the property east of Hwy 135. Discharge of firearms or bows is limited to outside of the designated safety zones, as posted.
- 3. West of Hwy 135, hunting is restricted allowed with to archery equipment for big game and shotguns utilizing birdshot for small game and for waterfowl only.
- 4. <u>Discharge of firearms or bows is prohibited in the designated safety zones, or as posted.</u> Public access prohibited from December 1 May 15 on that portion of the property east of Hwy 135.
- Fishing is prohibited in the fishing ponds and the connecting hatchery discharge stream to the hatchery outlet (on the East River) from the day after Labor Day through November 15.
- 6. Dogs are allowed but must be kept under control on a physical leash by the handler at all times, except when used as an aid in hunting.

## **Basis and Purpose:**

State Wildlife Areas (SWA) are areas purchased with money from the sale of hunting and fishing licenses and equipment. SWAs are purchased for a number of reasons, the primary one being to conserve wildlife and wildlife habitat needs. A secondary benefit is providing areas for wildlife-related recreation (hunting, fishing, and wildlife watching). When not in conflict with the prior purposes, SWAs also provide opportunities for other forms of recreation. Because SWAs are acquired using federal funds, if the U.S. Fish and Wildlife Service determines that a state agency has "lost control" of a property by allowing noncompatible uses, the state agency is required either to regain management control of the lands or replace such lands with lands of equal values and equal benefits as those originally acquired, or the license revenues must be restored to the State agency. Over the last 7-8 years State Wildlife Areas (SWA) use has dramatically increased, causing a corresponding rise in negative impacts on wildlife and wildlife related recreation. To combat these trends CPW has examined SWAs across the state and modified regulations to protect the wildlife and wildlife habitats found on these lands. These changes include updating the general provisions to be more restrictive and modifying language found in the property specific regulations. In addition to those restrictions, these changes also include additional property specific allowances that allow for activities that have been prohibited in the general provisions on those properties.

#### **Beaver Creek SWA**

Beaver Creek SWA is 2227 acres that include two small parking areas; there are no public restrooms or facilities. Beaver Creek is primarily managed for wildlife use and this includes planting food plots, rotation of grazing, and stream improvements. Beaver Creek SWA offers a very unique hunting and fishing opportunity. Hunters can hunt big game, small game, and turkey. Anglers can fish 3 miles of a continuous stream from the lower to the upper parking areas.

Beaver Creek SWA has become a more popular destination for activities not related to hunting and fishing. This proposed regulation will limit public access as follows: "Except for wildlife viewing from existing, established parking areas, the use of the property is restricted to hunting only from August 15 to April 30." It will reduce the overcrowding and loss of a quality hunting and angling experience. Turkey hunters have a five-year wait to draw a limited unit turkey license that is only valid for Beaver Creek SWA, and the connecting Table Mt STL. The proposed dates will also reduce conflicts between bear hunters during the September season, archery elk and deer hunters in September, rifle deer and elk hunters in October and November, and whitetail-only hunters in December. The winter and spring dates will provide valuable winter range habitats without dog and human disturbance.

### **Beaver Lake SWA**

Beaver Lake State Wildlife Area was purchased in 1961 by the State of Colorado. As written in the sale agreement from the previous landowner, Beaver Lake was sold to the State for "fishing purposes only." Recent recreation trends have led to non-angling water recreation overwhelming available parking and real estate on the water making it difficult to impossible for anglers to fish without becoming entangled. CPW continues to stock the lake 6-8 times annually with catchable trout. These trout are stocked on a

"put and take" basis encouraging angling and harvest. Beaver Lake is managed under statewide angling regulations with no additional angling restrictions in place. Many of the waters in the Roaring Fork valley are recognized as quality waters with either tackle restrictions, harvest restrictions or both.

Additionally, CPW annually receives complaints from Town of Marble residents who cannot leave or get to their house due to the number of SWA users who attempt to park along nearby roadways after the parking lot is full. CPW has engaged with local county commissioners and the Gunnison County Sheriff for the past several years who have requested CPW's assistance in corralling use which continues to sprawl onto the adjacent county roads making them impassable to local and emergency traffic. Patrols by CPW officers in the past several years have resulted in over 95% of the contacts being non-angling users. The regulation prohibiting non-angling related vessel use is meant to restore Beaver Lake as a unique angling opportunity where people can drive to water's edge, use bait and keep any fish caught.

## **Bighorn Springs SWA**

The newly acquired Bighorn Springs SWA offers users limited access and requires additional rules to protect the value of the unique qualities of this property. Bighorn Springs SWA is a fishing easement and the land is owned by the Blue Triton Corporation. The property is now in a Conservation easement that Colorado Parks and Wildlife helps to manage. Blue Triton pumps water from the aquifer beneath the surface and ships the product to be bottled and sold by Arrowhead Distributors. The easement agreement provides the public with access to the Arkansas River for fishing access, protection for bighorn sheep habitat, and wildlife viewing and education and interpretation from the newly created wildlife-viewing parking lot on County Road 302. Bighorn Springs SWA is in an area with a high demand for dispersed camping and sees heavy visitation being next to the Ruby Mountain AHRA site and the gateway to Browns Canyon National Monument. During the summer months, visitors are often not able to find a camping spot and will park in the Bighorn Springs SWA. Often trash is left behind and vehicles being left overnight can disrupt those user groups that want to use the property for the allowed uses.

The construction of the parking lot included an underlayment to protect any fuel sources from vehicles or other sources from any possible contaminations. The property only allows access from the parking lot and all access is restricted to foot traffic only. CPW and Blue Triton worked together to develop appropriate rules and regulations to protect the property. Both parties agreed that defined hours for usage should be implemented. The agreed-upon hours were from sunrise to a half-past sunset. This time allows for fishing access, but also eliminates potential conflicts at the property. A gate is installed and property hours can be posted on the gate and closed if necessary to control visitation hours. The terms of the access lease dictate management including the restriction of all dogs from the property. The property is managed for water quality and Blue Triton didn't want dogs on the property.

## **Burry State Wildlife Area (Fishing Lease)**

The addition of the Burry SWA (fishing lease) is to allow CPW to regulate and manage this property. Fishing access along the Roaring Fork River in Garfield County is very limited due to the river flowing through private properties. In June of 1994, Colorado Parks and Wildlife, formerly Colorado Division of Wildlife, purchased a fishing access easement and is still in private ownership. This easement allows for public fishing on the Roaring Fork River within boundaries agreed upon by both parties. CPW must adhere to all the terms and conditions of the lease agreement. Regulations put in place by CPW staff will allow for the terms and conditions to be met.

#### Cline Ranch SWA

Cline Ranch SWA requires updating to comply with changes to the Park County system. Park County owns the property and CPW has a perpetual access and management agreement for the property. When the property was originally acquired, Park County was hoping to allow for equestrian use. However, no trails were ever developed for equestrian use. At that time, the County Tourism and Community Development position was facilitating equestrian use requests. There were a few requests the first few years and there have been no known requests in the past 6-7 years. Approximately 2 years ago, this employee retired and Park County realigned their employee structure. Park County does not have an employee to facilitate this task. Park County agrees that with the lack of requests, the removal of the regulation is best for preventing any future frustration for constituents. With the lack of equestrian use requests and the addition of the SWA Access Pass, it was agreed that CPW staff could facilitate any requests for equestrian use. This will also align with making sure the equestrian use does not interfere with wildlife use and wildlife related recreation.

## **Coal Creek State Wildlife Area (Conservation Easement)**

The addition of the Coal Creek SWA (conservation easement) is to allow CPW to regulate and manage this property. In 2020, Colorado Parks and Wildlife purchased a conservation easement on Coal Creek Ranch. Along with the conservation easement, CPW received a 20-year access easement. This easement allows for public fishing on Coal Creek within boundaries agreed upon by both parties. CPW must adhere to all the terms and conditions of the lease agreement. Regulations put in place by CPW staff will allow for the terms and conditions to be met.

#### **Deweese Reservoir SWA**

Deweese Reservoir SWA is 2,153 acres with a 275 surface acre Reservoir. The property offers camping, fishing, hunting small and large game, and wildlife viewing. Over the last few years there has been an exponential increase in visitation comparable to some busier state parks. With the increased visitation comes the struggle to maintain facilities and habitat. There are only four vault toilets on the property and one camp host and one DWM to do maintenance and law enforcement. The proposed limiting of camping numbers and restricted areas of camping will lessen the impacts on the facilities, property and habitat.

Restricting where fires are allowed will also reduce trash and keep fire rings and glass out of the lake bed as the lake recedes each year. Prohibiting the use of glass containers at the lake will hopefully reduce the broken glass on the property. Prohibiting OHV use on the property will protect the resource by reducing off road activities as well as help with public safety. Restricting the use of snowmobiles to be only used as an aid to fishing will help with public safety and prevent conflict with ice fishermen and wildlife.

Deweese is unique in the fact that the fishing rights and the recreation rights are split between two different entities. Colorado Parks and Wildlife owns the fishing rights and property owners within the Lake Deweese Resort own the recreation rights. Therefore the general public is only allowed to fish from vessels. All other vessel recreation (i.e. jet skiing, water skiing, etc.) is restricted to only those deeded property owners within the Lake Deweese Resort.

#### Flanders Ranch SWA (Conservation Easement & Access Easement)

The addition of the Flanders Ranch SWA (conservation & access easements) is to allow CPW to regulate and manage this property. Fishing and hunting access along the Yampa River in Routt County is very

limited due to the river flowing through private properties. Colorado Parks & Wildlife purchased both conservation and access easements on Flanders SWA, but the property is still under private ownership. This easement allows for public fishing and hunting on the property within the scope, restrictions, and boundaries agreed upon by both parties. Flanders Ranch SWA access also provide the only legal and safe access to Hereford Haven SWA. CPW must adhere to all the terms and conditions of the conservation and access easements. Regulations put in place by CPW staff are to allow for these terms and conditions to be met.

## Frying Pan State Wildlife Area (Fishing Lease)

The addition of the Frying Pan River SWA (fishing lease) is to allow CPW to regulate and manage the property. Fishing access along the Frying Pan River in Eagle County is very limited due to the river flowing through private properties. In 1999, the Colorado Division of Wildlife now Colorado Parks and Wildlife, purchased a fishing access easements on three parcels that are still in private ownership. These easements allows for public fishing on the Frying Pan River within boundaries agreed upon by both parties. CPW must adhere to all the terms and conditions of the lease agreement. Regulations put in place by CPW staff will allow for the terms and conditions to be met.

## Harmon State Wildlife Area (SWA)

The Harmon SWA offers users limited access and requires additional rules to protect the values of the unique qualities of this property. The Harmon SWA is owned by the Town of Buena Vista and CPW has a perpetual fishing easement on ten acres of the property along Cottonwood Creek. The ten acres which consist of a trail and access to the river for fishing are adjacent to Buena Vistas water infiltration system which have monitors that measure data for water quality and disturbances. There is only one access to the property from a parking lot on County Rd 340 which provides ADA access for fishing on Cottonwood Creek. To protect the water infiltration monitoring system the Harmon SWA has additional regulations which prohibit any dogs from being on the property and users must remain on the trail.

This property is located in an area with a high demand for dispersed camping and sees heavy visitation, as the Harmon is just two miles west of Buena Vista along Cottonwood Pass. During the summer months, visitors are often not able to find a camping spot and will park in the Harmon SWA overnight and other groups like to park their vehicles to carpool or walk around for the evening. Often trash is left behind and vehicles being left overnight can disrupt those user groups that want to use the property for the intended use. Adding the regulation for defined hours of sunrise to half-hour past sunset to the Harmon SWA and the installation of a gate could help alleviate the after hour usage, littering, and overnight parking and eliminate the risk of any disturbance to the water infiltration system for the Town of Buena Vista.

#### Heckendorf SWA

The Heckendorf SWA is a 720-acre State Wildlife Area in the Upper Arkansas River Basin that consists of dryland pasture and mature Ponderosa Pine. Two parking areas provide access and there is a separate parking and viewing station. There are no public restrooms or facilities. Private property surrounds three sides and the northwest corner borders USFS property. CPW has added tree rows that consist of mountain mahogany, pinyon, and juniper. A junior water right feeds the irrigation system that consists of a storage pond, a buried 14-inch pipe, and a gated 10-inch pipe. The Heckendorf and its unobstructed connectivity to USFS land, and the Collegiate Peaks Wilderness provide the habitat required for the entire life cycle of numerous big game, small game, furbearers, and non-game species.

Increased recreational demands have increased use such as dog walking, kite skiing, skiing, snowshoeing, and jogging. The development of private property in the adjacent areas is negatively affecting habitat values. CPW proposes adding an additional regulation that would restrict access as follows: "Except for wildlife viewing from existing, established parking areas, the use of the property is restricted to hunting only from August 15 - April 30". This regulation will help to protect the core wildlife values of the property. The Heckendorf provides critical winter range for deer, elk, and pronghorn. Elk and mule deer will use the property from October – June before they transition to their summer range in the adjacent Collegiate Peaks Wilderness Area. Pronghorn will have their fawns and remain on the property for the entire summer and others will migrate to Lake County to summer on Hayden Flats. Coyotes, black bears, and raptors also frequent the property. Limiting access will also improve the hunting experience for the hunters that use the Heckendorf and have waited years for a big game license.

## Hereford Haven SWA (Conservation Easement & Access Easement)

The addition of the Hereford Haven SWA is to allow CPW to regulate and manage this property. Fishing and hunting access along the Yampa River in Routt County is very limited due to the river flowing through private properties. The access to the Hereford Haven SWA is only through the adjacent Flanders SWA (Hunting and Fishing Easement) property. CPW must adhere to all the terms and conditions of the conservation and access easements which affects regulations on Hereford Haven SWA. Regulations put in place by CPW staff are to allow for these terms and conditions to be met.

## Jackson State Wildlife Area (Fishing Lease)

The addition of the Jackson SWA (fishing lease) is to allow CPW to regulate and manage this property. Fishing access along the Roaring Fork River in Garfield County is very limited due to the river flowing through private properties. In June of 2009, Colorado Parks and Wildlife, purchased a fishing access easement that is still in private ownership. This easement allows for public fishing on the Roaring Fork River within boundaries agreed upon by both parties. CPW must adhere to all the terms and conditions of the lease agreement. Regulations put in place by CPW staff will allow for the terms and conditions to be met.

#### James M. John SWA

The James M John SWA is an 8200-acre CPW fee title owned property within Las Animas County, CO. This property provides unique public access for hunting, wildlife viewing, and wildlife related recreation. The James M John SWA is managed as a tier 1 property for big game, turkey, and small game. This SWA offers hunters a unique opportunity to applicants that successfully draw an access permit to hunt the property. This property is accessed via a trail through Lake Dorothey SWA. The SWA provides excellent habitat for deer, elk, bear and lion. This property serves as summer and winter range for both deer and elk. A CPW led research study also illustrated that this property serves as a critical habitat for elk calving during the summer months. In order to protect the unique habitat of this property and support wildlife, proposed regulations have been adopted to address concerns with human disturbance during critical periods, dogs, and the increased recreational use on SWA's. The access restriction helps protect wintering big game as well as calving periods for elk. This closure also aligns with the timing of the closure on Lake Dorothey SWA.

## **James Mark Jones SWA**

Currently camping has been allowed in the parking areas which have been slightly developed with the addition of fire rings to designate camping locations. With the recent increase in non-wildlife use on SWAs, it was recommended to allow camping by licenses hunters only, from August 14 through the end of the late elk season. This would prevent possible conflicts between non-wildlife recreational users and hunters during an extremely busy time on the SWA.

#### Lake Dorothey SWA

Lake Dorothey SWA is a 4800 acre leased property between the city of Raton, NM and Colorado Parks & Wildlife, (CPW). The lake Dorothey SWA provides public access for hunting, fishing, wildlife viewing, and wildlife related recreation. This property includes a ten acre lake and 3 miles of stream on Lake Dorothy SWA in addition to public access for the James M. John SWA and the Colorado portion of Lake Maloya. The property includes a parking area, trailhead, and restroom.

CPW and the city of Raton, NM re-negotiated a lease renewal in 2022 to include changes to the historic lease and greater flexibility for additional outdoor recreation. These negotiated changes resulted in hunters being able to pursue big game via archery, muzzleloader and rifle. Historically only archery hunting was allowed on the property. The regulation change removes archery hunting as the only method of take. Furthermore, big game hunter access for archery, muzzleloader and rifle seasons will be via an access permit. Access permits will be issued through a random drawing. This negotiated change results in greater high quality hunting opportunity while reducing any concerns with overcrowding.

Additionally, the city of Raton, NM and numerous public constituents wished to expand hiking opportunities on the property. CPW and the city of Raton agreed to allow limited hiking and biking on the SWA along four different trails. Specifically, trails A&B as designated on the map of the property are open to foot, bicycle and equestrian use. Trails C & D are open to foot and equestrian use only in addition to having timing stipulations to protect both wintering and calving elk. Public access to trails C & D are prohibited from December 1 through April 30<sup>th</sup> and from May 15 through June 30th with exception to licensed spring Turkey hunters. These negotiated lease changes will provide elk with valuable habitat at key times of the year without any human disturbance.

## Lon Hagler SWA

The update to these regulations brings them into compliance with current/historical signage and management. When night law enforcement is done on the property, officers check to see if users are actively fishing. If they are not, they are asked to leave. It was not until the statewide SWA chapter 9 update was undertaken that it was discovered that although we have historical/current signage stating it is closed unless actively fishing, we do not have it specified in regulation. The public expects our current management regarding access to continue. Area 2 has received a tremendous population influx in the past 10 years. This has resulted in more development and overall urbanization. Increases in drugs, alcohol, dumping, illegal transient camping and general SWA property destruction (including, but not limited to bathrooms, roads, signs, etc.) have also increased during this time, especially in the last 3 years. The Area believes this is at least partly due to these semi-urban/urban SWA's being an easy target for people trying to find secluded areas close to home/the city to do illegal activities. We simply do not have the staff to patrol these properties every night, let alone all night every night. Neither do our county law enforcement partners. The public will likely notice no change as it's the way we have been managing the property already. If anything, they would expect us to take steps to curb the destruction and increase safety. It will ultimately help keep us heading in a positive direction with SWA management in Area 2.

## **Mount Werner State Wildlife Area (Conservation Easement)**

The addition of the Mount Werner SWA (conservation easement) is to allow CPW to regulate and manage this property. Fishing and other wildlife recreation access along the Yampa River in Routt County is very limited due to the river flowing through private properties. In August of 1991, Colorado Parks and Wildlife, formerly Colorado Division of Wildlife, purchased a conservation easement and is still under City of Steamboat Springs ownership. This easement allows for public fishing and other wildlife recreation on the property within the scope, restrictions, and boundaries agreed upon by both parties. CPW must adhere to all the terms and conditions of the conservation easement. Regulations put in place by CPW staff will allow for the terms and conditions to be met.

#### **Queens SWA**

Queens State Wildlife Area consists of multiple reservoirs. Over the past decade, there have mainly been four reservoirs that have held water. These are Ne Gronde, Ne Noshe, Upper Queens and Lower Queens. Due to the drought, when these reservoirs have received water they do not get filled completely and have been smaller bodies of water.

With smaller bodies of water, we have seen an increase in competition for usage. Delineating the usage of the different reservoirs will help alleviate that competition. Ne Noshe will have regulations, "All water contact activities are allowed" and "Launching and use of all vessels is allowed" while Ne Gronde, Upper Queens, and Lower Queens will limit boat access to hunting and fishing. This was chosen since Ne Noshe keeps boat access, as depths go down, longer than any of the other reservoirs and to minimize conflict. All vessels and water contact activities are still allowed on other area reservoirs such as Adobe Creek/Blue Lake and John Martin.

#### Roaring Fork/Gianinetti State Wildlife Area (Fishing Lease)

The addition of the Gianinetti SWA (fishing lease) is to allow CPW to regulate and manage this property. Fishing access along the Roaring Fork River in Garfield County is very limited due to the river flowing through private properties. In October of 1987, Colorado Parks and Wildlife, formerly Colorado Division of Wildlife, purchased a fishing access easement that is still in private ownership. This easement allows for public fishing on the Roaring Fork River within boundaries agreed upon by both parties. CPW must adhere to all the terms and conditions of the lease agreement. Regulations put in place by CPW staff will allow for the terms and conditions to be met.

#### San Luis Hills SWA

San Luis Hills is mostly wild landscape vital to many wildlife species, including several big game species. Costilla County owns the property, and CPW manages it through a cooperative agreement with the County. Both entities believe it is critical to maintain a low level of human presence and use. Restricting camping and campfires to those engaged in hunting and fishing activities is consistent with the intended use for this area by said entities.

#### Steamboat Springs State Wildlife Area (Conservation Easement)

The addition of the Steamboat Springs SWA (conservation easement) is to allow CPW to regulate and manage this property. Fishing and other wildlife recreation access along the Yampa River in Routt County is very limited due to the river flowing through private properties. In March of 2001, Colorado Parks and

Wildlife, formerly Colorado Division of Wildlife, purchased a conservation easement and is still under City of Steamboat Springs ownership. This easement allows for public fishing and other wildlife recreation on the property within the scope, restrictions, and boundaries agreed upon by both parties. CPW must adhere to all the terms and conditions of the conservation easement. Regulations put in place by CPW staff will allow for the terms and conditions to be met.

## **Two Buttes SWA**

The Black Hole consists of a series of spring-fed wetland complexes that start at the base of the Two Buttes Reservoir dam and run eastward to the end of the State Wildlife Area property line approximately ¾ of a mile. The central and largest pond is bordered by large rock cliffs that are used for cliff jumping as well as partying. At times this includes 400 to 500 people in this area of the property. Over the years this has led to damage to the resource as well as many violations by visitors. There have been several occasions of alcohol and drug violations found by both CPW officers as well as the local Sheriff's office. Along with these violations, there have been several injuries as well as deaths that have occurred in the Black Hole portion of the property. By adding "Water contact activities are allowed on the reservoir only" we will stop cliff jumping/swimming on the ponds below the dam and alleviate many of the issues on this portion of the property.

# **Upper Red Cliff Ranch SWA**

The addition of the Upper Red Cliff Ranch SWA is to allow CPW to regulate and manage this 480-area property located just outside of the town of Beulah. Colorado Parks and Wildlife acquired the property through CPW's RFP program and it is currently being developed as a site for public hunting, fishing and wildlife related recreation. Regulations put in place by CPW staff will allow for the proper management of the area.

#### **Wellington SWA**

Currently Wellington SWA allows access on Saturday, Sunday, Monday and state and federal holidays. All the other SWAs in the Area allow access on Saturday, Sunday, Wednesday and state and federal holidays. Leaving Monday as an access day on Wellington SWA was an over sight when the other SWA regulations were changed from Mondays to Wednesdays. The Area did this change previously to help with getting birds to settle down after being hunted on consecutive days (Saturday & Sunday), in an attempt to provide better hunting opportunities for users. By completing this change there will actually be more days available for public use.

EFFECTIVE DATE - THESE REGULATIONS SHALL BECOME EFFECTIVE AUGUST 1, 2023 AND SHALL REMAIN IN FULL FORCE AND EFFECT UNTIL REPEALED, AMENDED OR SUPERSEDED.
