Respiratory Therapy applicants granted this temporary licensure shall practice under the direct supervision of a Colorado licensed respiratory therapist in good standing during the entire term of the temporary licensure. 	
	a. For the purpose of this emergency rule, "direct supervision" means the Colorado licensed respiratory therapist must be on the premises with the temporary respiratory therapy licensee and immediately available to respond to an emergency or provide assistance.	
	b. For the purpose of this emergency rule, "premises" means within the same building, office or facility and within the physical proximity to establish direct contact with the patient should the need arise.	Formatted: par3
