DENVER BASIN AQUIFER AND NONTRIBUTARY GROUNDWATER AQUIFER ARTIFICIAL RECHARGE EXTRACTION RULES (2 CCR 402-11)

On Tuesday May 1, 2018 the State Engineer will be holding a public rulemaking hearing, pursuant to section 24-4-103(4)(a), C.R.S. At the hearing, the State Engineer will afford interested persons an opportunity to submit and present written or oral data, views, or arguments for consideration by the State Engineer. This Notice contains information on how to participate at the hearing in person and to submit written comments or testimony for consideration by the State Engineer.

To Participate at the Hearing (Oral or Written Testimony)

Submit Application for Party Status by April 20, 2018

- The Application must list the following: name, U.S. mail address, telephone number and e-mail address of the Person, Persons or Agency seeking Party Status. The application shall also indicate the interest of the Person(s) or Agency in the proposed rules and a description of the general nature of the evidence to be presented by the proposed Party in the course of the proceedings.

- If you submit an Application by the above the deadline, you will be given party status.
- If you do not submit a Application by the above deadline, you may still be given an opportunity to provide comments during the hearing as an interested person, but you may not be granted party status, and the time to present your comments may be limited.

To Give Oral Testimony at the Hearing

- Submit a Prehearing Statement by **April 23, 2018** that includes the following
 - Anticipated scope of testimony, including the specific proposed rules on which the party or individual will testify
 - Requested length of testimony for each proposed rule on which the party or individual will testify
 - Whether the party or individual intends to present documentary, audio, or visual evidence at the hearing, including any audio/visual presentation requirements

- Comments not designated as “testimony” will be made available to the Board prior to the hearing.
