SUBJECT: NOTICE OF PUBLIC HEARING TO CONSIDER REPEAL

All interested persons are invited to attend this public hearing and to submit comments to the BAA for consideration concerning the proposed rules.

3. Oral comments may be provided at the hearing as follows:
 - a. All persons wishing to provide oral comment must sign up to do so at the hearing, noting who they represent.
 - b. Any person wishing to provide oral comment will be limited to five minutes of time.


- c. Any person signing up to speak may cede any portion or all of their time to another speaker.
- d. Any speaker may have up to but no more than two people cede their time to the speaker.
- e. At their discretion, the Hearing Officer may limit or extend the time of any speaker.
