## Notice of Public Rule-Making Hearing Before The Chief Medical Officer October 20, 2021

NOTICE is hereby given pursuant to the provisions of Section 24-4-103, C.R.S., that the Chief Medical Officer will conduct a public rule-making hearing on October 20, 2021 at 11 a.m. remotely over Zoom at this [link](#), to consider the revision of 6 CCR 1015-3 Emergency Medical Services Chapter Two, Rules Pertaining to EMS Practice and Medical Director Oversight. The proposed rule has been developed by the Health Facilities and Emergency Medical Services Division of the Colorado Department of Public Health and Environment pursuant to Sections 25-3.5-203(1)(a.5), 25-3.5-206(4)(a), 25-3.5-103, (8.6) and (10.3), 25-3.5-206 (2)(a), and 25-3.5-209, C.R.S.

The agenda for the meeting and the proposed amendments will also be available on the Executive Director's website, <https://cdphe.colorado.gov/executive-director-rule-making-hearings> at least seven (7) days prior to the meeting. The proposed rules, together with the proposed statement of basis and purpose, specific statutory authority and regulatory analysis will be available for inspection at the Colorado Department of Public Health and Environment, 4300 Cherry Creek Drive South EDO-A5, Denver, Colorado 80246-1530 at least five days prior to the hearing. The Chief Medical Officer encourages all interested persons to participate in the hearing by providing written data, views, or comments. Written testimony is encouraged; oral testimony will be received only to the extent the Chief Medical Officer finds it necessary. For those that are permitted to provide oral testimony, the time may be limited to 3 minutes or less. Testimony is limited to the scope of the rulemaking hearing. Written testimony must be submitted no later than five (5) calendar days prior to the rulemaking hearing. Written testimony must be received by 5:00 p.m., Thursday, October 14, 2021.
