Specifically, the public record will remain open, and a second hearing will be held.

The topics to be considered during the extended comment period are:

Appeals

To amend the rules related to unemployment insurance appeals for clarity and further discussion regarding transcripts of hearings.

Good Cause

To amend the rules related to good cause for clarity.

Employee Misclassification

To adopt rules allowing the Unemployment Insurance Program to fine an employer who is found to have willfully disregarded the law when misclassifying an employee as an independent contractor.

The Program strongly urges stakeholders to take advantage of the extended comment period to provide additional information, recommendations, and data on the issues covered in the proposed rules that may impact them. The Program strives to promote regulations that maximize the efficiency and effectiveness of Colorado's unemployment insurance system. The Program believes extending the comment period allows stakeholders to provide more valuable information that will help the Program achieve these goals.
