STIPULATION


1. This matter was originally set for hearing on August 8, 2011 before the Colorado Oil and Gas Conservation Commission ("COGCC" or "Commission") on proposed amendments to Rule 318A applicable to the Greater Wattenberg Area (GWA). On August 3, 2011, the City and County of Broomfield ("Broomfield") objected to the proposed Rule 318A amendments on grounds Broomfield did not have adequate time to evaluate the proposed amendments. The proposed Rule 318A amendments were adopted as Rule 318A(l), which applies to GWA, excluding Broomfield.
2. Subsequently, the COGCC initiated rulemaking to apply Rule 318A(l) to Broomfield. This matter has been set for hearing before the Commission on several occasions, but each time Broomfield requested, and the Staff agreed to, a continuance.
3. Most recently, this matter was set for hearing on August 20, 2012. On August 15, 2012, Broomfield requested a continuance to the October 1, 2012 hearing. Commission Staff again agreed to the continuance, but advised Broomfield further requests for continuances almost certainly would be denied.
4. On September 25, 2012, Broomfield requested the matter be continued to the November 15, 2012 hearing. Commission Staff advised Broomfield it would agree to a continuance only on the condition Broomfield stipulate to entry of a Commission directive that Broomfield not be granted any further continuance in this matter.
5. NOW, THEREFORE, the parties hereby stipulate that this matter will be continued to the November 15-16, 2012 hearing on the condition that the Commission directs the Secretary that no further continuances shall be granted at Broomfield's request.
6. Nothing in this stipulation prohibits any action or relief as authorized by the Rules and Regulations of the Colorado Oil and Gas Conservation Commission, the State Administrative Procedure Act, and the Rules of Civil Procedure.
