2. Due to the lack of verification of the information above, people who are scammed or done wrong by businesses will have no recourses to be able to take them to the small claim courts. The judicial branch requires notices to be delivered to the person who is named as the registered owner. If the information is wrong and made up, there is no way to pursue them through the simple channels.
