

CAMPAIGN AND POLITICAL FINANCE 2012 MUNICIPAL FILING CALENDAR

This calendar applies to all municipal candidates and county committees in 2012. The top portion – the frequent calendar – applies to:

- Political Committees
- Small Donor Committees
- 527 Political Organizations
- Political Parties
- Independent Expenditure Committees
- Candidates and Candidate Committees whose office will appear on a 2012 ballot
- Issue Committees whose issue will be on or who attempts access to a 2012

The second calendar – the infrequent/annual calendar – applies to those candidates, candidate committees or issue committees whose candidate or issue will not be on or attempt access to the 2012 General Election ballot. The below calendar assumes that a municipal election will be held at the same time as the November 6, 2012 General Election. Check with municipal clerk for report due dates and reporting periods if an election is held on another date.

June 22, 2012 (Friday)	June 1, 2012 through June 17, 2012
July 26, 2012 (Thursday)	June 18, 2012 through July 21, 2012
October 16, 2012 (Tuesday)	July 22, 2012 through October 11, 2012
November 2, 2012 (Friday)	October 12, 2012 through October 28, 2012
December 6, 2012 (Thursday)	October 29, 2012 through December 1, 2012

Infrequent/Annual Calendar

2011 ANNUAL REPORT DUE DATE	REPORTING PERIOD
November 1, 2012 (Thursday)	October 28, 2011, through October 27, 2012 <i>(Committees filing on the <u>infrequent/annual</u> schedule in 2011 remaining infrequent filers in 2012)</i> OR November 27, 2011 through October 27, 2012 <i>(Committees filing on the <u>frequent</u> schedule in 2011, changing status to infrequent/annual filers in 2012)</i>

Note: These calendars do not include the 24 Hour Notice of Major Contributor or the 48 Hour Notice of Independent Expenditure reports that may be required based on certain activity within a committee. The period during which these reports may be required begins 30 days before the primary and general election (May 27th and October 7th respectively) and runs through the date of the election. Please refer to the Campaign Finance Manual for information detailing when these reports may be required.
