2013 SPECIAL DISTRICT ANNUAL REPORT FILING CALENDAR

Inquiries regarding special district elections should be directed to the DEO (Designated Election Official) or the Department of Local Affairs. Campaign Finance disclosure reporting questions should be directed to the Secretary of State's campaign finance support team.

This calendar applies to:

Active and or open (not yet terminated) special district candidates, committees, and 527 political organizations whose candidates or issues will not appear on a 2013 ballot.

May

1 Annual report covers:

- April 27, 2012 through April 26, 2013

OR

- June 3, 2012 through April 26, 2013

An annual report must be filed by committees that remain open (i.e. those not yet terminated) no later than the first business day of the month in which the anniversary of the election occurs.

Special district candidates and committees who are involved with a special district election that will be held in conjunction with the November 5, 2013 Coordination Election would file their disclosure reports according to the 2013 County Frequent Filing Calendar.

Note: Special district candidates and candidate committees are not required to file disclosure reports until they have raised or spent more than \$200 in the aggregate.

The following reports are not required in odd calendar years:

- 24 Hour Notice of Major Contributor
- 48 Hour Notice of Independent Expenditure
