

## CAMPAIGN AND POLITICAL FINANCE

### 2015 SPECIAL DISTRICT ANNUAL REPORT FILING CALENDAR

*Special District Election questions should be directed to the Designated Election Official (DEO) or the Department of Local Affairs. Campaign Finance questions should be directed to the Secretary of State's office.*

**This calendar applies to** (Refer to Campaign Finance Rule 17):

- Candidates and candidate committees whose office **does not** appear on a 2015 ballot
- Issue committees whose issue **does not** attempt access to or appear on a 2015 ballot
- All other non-terminated special district committees (political and small donor committees, 527 political organizations, independent expenditure committees, etc.) whose candidates or issues do not attempt access to or appear on a 2015 ballot

#### May

1 Annual report covers:

- April 27, 2014 through April 26, 2015

**OR**

- June 1, 2014 through April 26, 2015

An annual report must be filed by committees that remain open (i.e. those not yet terminated) no later than the first business day of the month in which the anniversary of the election occurs.

Special district candidates and committees, involved with a special district election held in conjunction with the November 3, 2015 Coordination Election, file disclosure reports according to the 2015 County Frequent Filing Calendar.

*Note: Special district candidates and candidate committees are not required to file disclosure reports until they have raised or spent more than \$200 in the aggregate.*

**The following types of reports are not required in odd calendar years:**

- 24 Hour Notice of Major Contributor
- 48 Hour Notice of Independent Expenditure
- Electioneering Communication Reports
