**This calendar does not include the 24 Hour Notice of Major Contributor or the 48 Hour Notice of Independent Expenditure reports** that may be required based on certain activity. The period during which these reports may be required begins 30 days before the primary and general election and ends the day before the election.

**Electioneering communications reports may also be required** beginning 30 days before a Primary and 60 days before a General. Refer to the Campaign Finance manual for more information.
