15 2015 **4th Quarter** Report covers October 1, 2015 through December 31, 2015

Note: Does not include committees that last filed December 3, 2015.

These committees file next on April 15, 2016, with a reporting period of December 1, 2015 through March 31, 2016.

15 2015 **Annual Report** covers January 1, 2015 through December 31, 2015.

Note: Annual reports only apply in specific instances for some candidate committees. Reporting period for annual report may differ from above; contact the campaign finance support team with questions.
