2017 COUNTY INFREQUENT/ANNUAL FILING CALENDAR

Use this calendar if you are NOT participating in the November 7, 2017 Biennial School Election.

Law and Rule reference cites: 1-45-108(2), C.R.S. & Campaign and Political Finance Rule 17

This calendar applies to:

- County Candidates and Candidate Committees whose offices do not attempt access to or appear on the November 7, 2017, Coordinated Election / Biennial School Election ballot
- Junior College Board of Trustee Candidates (for Northwestern Community college) whose offices do not attempt access to or appear on the November 7, 2017, Coordinated Election ballot
- County Issue Committees (IC)* whose issue does not attempt access to or appear on the November 7, 2017 Coordinated Election / Biennial School Election ballot
- County Political Parties (PP)*
- County Political Committees (PC)*
- County Small Donor Committees (SDC)*
- County 527 Political Organizations (527 PO)*
- County Independent Expenditure Committees (IEC)*

* Any candidate, party, or committee **participating in the November 7, 2017, Biennial School Election must file disclosure reports according to the 2017 Biennial School Election Schedule.** You must notify Campaign Finance Support to update your filing schedule immediately upon participating in the biennial school election.

November

1 Annual Report covers:

- October 28, 2016 through October 27, 2017

OR

- December 4, 2016 through October 27, 2017

Notes:

- **Due to a change in the law, the following types of reports are now required in odd calendar years:**
 - *Electioneering Communication* reports starting 60 days (September 8, 2017) before the Biennial School Election if the communication mentions school board candidates
 - *24 Hour Notice of Major Contributor* reports (starting October 8, 2017 through November 6, 2017)
 - *48 Hour Notice of Independent Expenditure* reports (starting October 8, 2017 through November 6, 2017)
- Small-Scale Issue Committees (SSIC) are not required to file disclosure reports until they exceed \$5,000 in activity. After filing an initial disclosure report and converting to an Issue Committee, they are subject to the disclosure requirements of 1-45-108, C.R.S.
