

## CAMPAIGN AND POLITICAL FINANCE

### 2017 MUNICIPAL FREQUENT AND ANNUAL FILING CALENDAR

*If the municipal election isn't held on November 7, 2017, contact the municipal clerk for filing deadlines. Home Rule municipalities may have a different filing schedule; check with your municipal clerk to verify disclosure dates.*

**Frequent calendar** applies to not yet terminated:

- Candidates or candidate committees whose office will appear on the November 7, 2017 Coordinated Election ballot
- Issue committees whose issue attempts access to or appears on the November 7, 2017 Coordinated Election ballot

#### October

17 21st Day before the Election Report covers:

- October 28, 2016 through October 12, 2017

**OR**

- December 4, 2016 through October 12, 2017

#### November

3 Friday before the Election Report covers October 13, 2017 through October 29, 2017

**7 2017 Coordinated Election**

#### December

7 Post-Election Report covers October 30, 2017 through December 2, 2017

**Infrequent/Annual calendar** applies to not yet terminated:

- Candidates and candidate committees whose office does not appear on the November 7, 2017 Election ballot
- Issue committees whose issue does not attempt access to or appear on the November 7, 2017 Election ballot
- Political Committees (PC)
- Small Donor Committees (SDC)
- 527 Political Organizations (527 PO)
- Political Parties (PP)
- Independent Expenditure Committees (IEC)

#### November

1 Annual Report covers:

- October 28, 2016 through October 27, 2017

**OR**

- December 4, 2017 through October 27, 2017

#### Notes:

- **Due to a change in law, the following types of reports are now required in odd calendar years:**
  - *Electioneering Communication* reports starting 60 days (September 8, 2017) before the Biennial School Election if the communication mentions school board candidates
  - *24 Hour Notice of Major Contributor* report (starting 30 days before the election, October 8, 2017 through November 6, 2017)
  - *48 Hour Notice of Independent Expenditure* report (starting 30 days before the election, October 8, 2017 through November 6, 2017)
- Any PCs, SDCs, 527 POs, and IECs participating in the November 7, 2017, Biennial School Election must file disclosure reports according to the 2017 Biennial School Election schedule. You must notify your appropriate filing office to update your filing schedule immediately upon participating in the Biennial School election.
- Small-Scale Issue Committees (SSIC) are not required to file disclosure reports until they exceed \$5,000 in activity. After filing an initial disclosure report and converting to an Issue Committee, they are subject to the disclosure requirements of 1-45-108(2), C.R.S.
