2018 SPECIAL DISTRICT FREQUENT AND ANNUAL
FILING CALENDAR**

Special District Election questions should be directed to the Designated Election Official or the Department of Local Affairs. Campaign Finance questions should be directed to the Secretary of State's office.

Frequent calendar Refer to Campaign Finance Rule 17:

- Candidates and candidate committees whose office appears on the May 8, 2018 Special District Election ballot
- Issue Committees whose issue attempts access to or appears on the May 8, 2018 Special District Election ballot
- All other active special district committees (political and small donor committees, 527 political organizations, independent expenditure committees) whose candidates or issues attempts access to or appears on the May 8, 2018 Special District Election ballot

April

17 21st Day before the Election - report covers April 27, 2017 through April 12, 2018

May

4 Friday before the Election - report covers April 13, 2018 through April 29, 2018

8 Regular Biennial Special District Election

June

7 30th day after the Election - report covers April 30, 2018 through June 2, 2018

Infrequent/Annual calendar Refer to Campaign Finance Rule 17:

- Candidates and candidate committees whose office **does not** appear on the May 8, 2018 Special District Election ballot
- Issue committees whose issue **does not** attempt access to or appear on the May 8, 2018 Special District Election ballot

An annual report must be filed by committees that remain open (i.e. those not yet terminated) no later than the first business day of the month in which the anniversary of the election occurs.

May

1 Annual report covers April 27, 2017 through April 26, 2018

Notes:

- The following types of un-scheduled reports **are also required**:
 - 24 Hour Notice of Major Contributor report periods occurs 30 days before both the June 26, 2018 Primary and November 6, 2018 General Elections. These reports do not apply to 527s and IECs.
 - 48 Hour Notice of Independent Expenditure report periods occur 30 days before both the June 26, 2018 Primary and November 6, 2018 General Elections. IECs only.
 - 30 day time period for 24 & 48 hour reports before the Primary Election starts May 27, 2018 and concludes on June 25, 2018.
 - 30 day time period for 24 & 48 hour reports before the General Election starts October 7, 2018 and concludes on November 5, 2018.
- Special district candidates and candidate committees are required to file disclosure reports once they have raised or spent more than \$200 in the aggregate.
- Small-Scale Issue Committees (SSIC) file disclosure reports once they exceed \$5,000 in activity. After filing an initial disclosure report and converting to an Issue Committee, they are subject to the disclosure requirements of 1-45-108, C.R.S.
