FILING CALENDAR**

This calendar applies to (refer to Campaign Finance Rule 17):

- State candidates and state candidate committees whose office **does NOT** appear on the June 30, 2020 Primary or November 3, 2020 General Election ballots.
- State Issue committees whose issue **does NOT** attempt access to or appear on the November 3, 2020 General Election ballot.

Please note:

- *Electioneering Communication (EC)* mentions candidates and are part of the regularly scheduled reports for registered committees. EC reports do not apply to Issue Committees.
- *24 Hour Notice of Major Contributor* reports do not apply to 527s and IECs.
- *48 Hour Notice of Independent Expenditure* reports only apply to IECs.
- Small-Scale Issue Committees (SSIC) file disclosure reports once they exceed \$5,000 in activity. After filing an initial disclosure report and converting to an Issue Committee, they are subject to the disclosure requirements of 1-45-108, C.R.S.
