

CAMPAIGN AND POLITICAL FINANCE 2022 COUNTY FREQUENT FILING CALENDAR

This calendar applies to (refer to Campaign Finance Rule 17):

- County candidates and candidate committees whose office appears on the 2022 Primary or General Election ballot
- County Issue committees whose issue attempts access to or appears on the 2022 General Election ballot
- County Political Parties
- County Political Committees
- County Small Donor Committees
- County 527 Political Organizations
- County Independent Expenditure Committees

Please note:

- Electioneering Communication (EC) mentions candidates and are part of the regularly scheduled reports for registered committees. EC reports do not apply to Issue Committees.
- 24-Hour Major Contributor Reports do not apply to PCs, 527s and IECs.
- 48-Hour Independent Expenditure Reports only apply to IECs.
- Small-Scale Issue Committees (SSIC) file disclosure reports once they exceed \$5,000 in activity. After filing an initial disclosure report and converting to an Issue Committee, they are subject to the disclosure requirements of 1-45-108, C.R.S.

May

29 Starts the 30-day period before the Primary election for 24-Hour Major Contributor & 48-Hour Independent Expenditure reports and concludes on June 27, 2022

29 Starts the time period for Electioneering Communications and continues through November 7, 2022

June

7 21st Day before the Primary Election - report covers:

- October 28, 2021 through June 2, 2022

OR

- November 28, 2021 through June 2, 2022

24 Friday before the Primary Election - report covers June 3, 2022 through June 19, 2022

28 Primary Election

July

28 30th Day after the Primary Election - report covers June 20, 2022 through July 23, 2022

October

9 Starts the 30-day period before the General Election for 24-Hour Major Contributor and 48-Hour Independent Expenditure reports and concludes on November 7, 2022

18 21st Day before the General Election - report covers July 24, 2022 through October 13, 2022

November

4 Friday before the General Election - report covers October 14, 2022 through October 30, 2022

8 General Election

December

13 35th Day after the General Election - report covers October 31, 2022 through December 8, 2022

Federal/State holidays are denoted in red; the office may be closed on these dates.
