Section 24-6-203 C.R.S.

This calendar applies to state, county, and/or local elected candidates or incumbents, including Judges/Justices. All candidates or incumbents required to file this report file with the Secretary of State’s office; except for municipal candidates/incumbents, who file with their municipal clerk.

Filing is only required if a candidate/incumbent has something to report; if there is nothing to report, the filing is voluntary but encouraged.

This report is now required to be filed electronically through TRACER (except for municipal jurisdictions), the Secretary of State’s Campaign Finance website. The Report is available under the Online Forms section at:
