

CAMPAIGN AND POLITICAL FINANCE 2023 STATE FREQUENT (MONTHLY / BIWEEKLY) FILING CALENDAR

Federal/State holidays are denoted in red; the office may be closed on these dates.

This calendar applies to (refer to Campaign Finance Rule 17):

- **State issue committees** whose issue attempts access to or appears on the November 7, 2023 Coordinated Election ballot.

Notes:

- **Small-Scale Issue Committees (SSIC)** are not required to file disclosure reports until they exceed \$5,000 in activity. After filing an initial disclosure report and converting to an Issue Committee, SSICs are subject to the disclosure requirements of 1-45-108(2), C.R.S.
- **24 Hour Notice of Major Contributor (MC) report** period starts 30 days before the Biennial School Board Election and concludes the day before the election. **Report is due within 24 hrs. of receiving a Major Contribution. Applies Issue Committees whether they are or are not participating in the election. It also applies to candidate committees whose office appears on the Biennial School Election ballot.**
