Petitioner, the Secretary of State of the State of Colorado, through the Office of the Attorney General, submits the following notice that this matter and the hearing currently scheduled before the Office of Administrative Courts is being transferred to a Secretary of State Hearing Officer, and states:

1. Pursuant to Rule 3.18 of the Secretary's General Procedural Rules for Administrative hearings, "[u]pon motion by the division, any administrative complaint pending before the Office of Administrative Courts shall be transferred to a hearing officer as provided in for these rules. The administrative complaint will proceed uninterrupted." 8 C.C.R. 1505-3, Rule 3.18.

2. A “Hearing Officer” means a person authorized to conduct a hearing under section 24-4-105(3), C.R.S. and is not the division or its designee in which an initial complaint was filed. 8 C.C.R. 1505-3, Rule 3.2.8.

3. The matter is currently set for hearing at the Office of Administrative Courts on May 5, 2025, at 9:00 a.m.

4. Petitioner is simultaneously filing a Motion to Transfer with the Office of Administrative Courts.

5. In accordance with Rule 3.18, Petitioner requests that the Hearing Officer maintain that the hearing be held on May 5, 2025 at 9:00 am.
