BE IT ENACTED BY THE PEOPLE OF THE STATE OF COLORADO:

SECTION 1. THE COLORADO GENERAL ASSEMBLY, AND THE COLORADO CONSTITUTION FINDS AND DECLARES THAT

COLORADO CONSTITUTUTION, BILL OF RIGHTS, ARTICLE II SECTION 6.:

THE COURTS OF JUSTICE SHALL BE OPEN TO EVERY PERSON, AND A SPEEDY REMEDY AFFORDED FOR EVERY INJURY TO PERSON, PROPERTY, OR CHARACTER; AND THAT RIGHT AND JUSTICE SHOULD BE ADMINISTERED WITH-OUT SALE. DENIAL. OR DELAY.
