CONSOLIDATED METROPOLITAN DISTRICT BALLOT ISSUE NO. 5B:

SHALL CONSOLIDATED METROPOLITAN DISTRICT'S ANNUAL RECREATION FEE BE INCREASED FROM ITS CURRENT LEVEL OF \$205 TO AN AMOUNT NOT TO EXCEED \$240 IN 2010; AND IN EACH YEAR THEREAFTER FOR A PERIOD NOT TO EXCEED SEVEN CALANDER YEARS SHALL THE RECREATION FEE BE INCREASED ANNUALLY AT THE DISCRETION OF THE BOARD OF DIRECTORS IN AN AMOUNT NOT TO EXCEED 5% OR THE RATE OF INFLATION ESTABLISHED BY THE DENVER/BOULDER COLORADO CPI INDEX, WHICHEVER IS LESS, (SAID INCREASES TO BE CUMULATIVE) TO GENERATE REVENUES TO PAY THE COST OF CONSTRUCTING, ACQUIRING, PROVIDING, OPERATING, MAINTAINING, IMPROVING OR REPLACING THE DISTRICT'S RECREATIONAL FACILITIES, IMPROVEMENTS, EQUIPMENT, SERVICES AND PROGRAMS; AND SHALL THE PROCEEDS OF SUCH FEES AND INVESTMENT INCOME THEREON CONSTITUTE VOTER-APPROVED REVENUE CHANGES AND BE COLLECTED AND SPENT BY THE DISTRICT EACH YEAR, WITHOUT LIMITING OR AFFECTING THE COLLECTION OR EXPENDITURE OF OTHER REVENUES, AND WITHOUT REGARD TO ANY SPENDING, REVENUE RAISING, TAX REDUCTION OR OTHER LIMITATION CONTAINED WITHIN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION?
