

RESOLUTION NO. 2010-6

A RESOLUTION CANCELING THE CAÑON CITY AREA METROPOLITAN RECREATION AND PARK DISTRICT'S 2010 ELECTIONS, DEEMING CANDIDATES ELECTED, AND PROVIDING NOTICE THEREOF

WHEREAS, pursuant to C.R.S. § 1-5-208, the Cañon City Area Metropolitan Recreation and Park District may cancel its election for the nonpartisan Board of Directors if that is the only matter before the electors in the election and if there are not more candidates than offices to be filled at the election; and,

WHEREAS, the election of the Board of Directors is the only matter before the electors in the District's May 4, 2010 election; and,

WHEREAS, there are not more candidates for the Board of Directors than offices to be filled at the election; and,

WHEREAS, the District wishes to cancel its election scheduled for May 4, 2010 and declare the candidates elected.

THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CAÑON CITY AREA METROPOLITAN RECREATION AND PARK DISTRICT THAT:

1. The Board of Directors of the Cañon City Area Metropolitan Recreation and Park District hereby certifies that there were not more candidates for director than offices to be filled, including candidates filing affidavits of intent to be write-in candidates, and cancels the election currently set for May 4, 2010, and further declares the candidates for the Board of Directors in that election elected as follows:

2. The District staff shall cause notice of this cancellation to be published in accordance with C.R.S. § 1-5-208 (6).
3. The District staff shall cause a copy of the notice of this cancellation to be posted at each polling place of the political subdivision, in the office of the Designated Election Official, and in the office of the Fremont County Clerk

and Recorder, and a copy of the notice shall be filed with the Division of Local Government.

4. The District staff shall notify the candidates that the election was canceled and that they were elected by acclamation.


