NOTICE IS HEREBY GIVEN that the election to be held on the 4th day of May, 2010, has been cancelled. All candidates were elected by acclamation.



RESOLUTION NO. 10- 02

APPOINTING DESIGNATED ELECTION OFFICIAL AND AUTHORIZING
DESIGNATED ELECTION OFFICIAL TO CANCEL ELECTION

WHEREAS, pursuant to C.R.S. §§ 1-1-111(2) and 32-1-804(2), the Board of Directors of the East River Regional Sanitation District ("the Board") is authorized to designate an election official to exercise all powers and authority of the Board in conducting regular and special elections; and

WHEREAS, pursuant to C.R.S. § 1-5-208, the Board may authorize the designated election official to cancel the election upon certain conditions.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE EAST RIVER REGIONAL SANITATION DISTRICT:


1. The Board hereby appoints Mike Billingsley as the Designated Election Official for the East River Regional Sanitation District to exercise all powers and authority of the Board in conducting the regular election scheduled for the 4th day of May 2010.

2. The Board hereby authorizes and directs the Designated Election Official to cancel said election and declare the candidates elected if, at the close of business on the sixty-third day before the election, or March 2, 2010, there are not more candidates than offices to be filled at the election, including candidates filing affidavits of intent to be write-in candidates, and no ballot issues or questions to be submitted to eligible electors.


3. The Board hereby authorizes and directs the Designated Election Official to publish notice of the cancellation; post a copy of the notice at each polling place, in the office of the Designated Election Official, and in the office of the clerk and recorder for each county in which the East River Regional Sanitation District is located; file a copy of the notice with the Division of Local Government; and notify the candidates that the election was canceled and that they were elected by acclamation.
