The undersigned Designated Election Official for the Elizabeth Fire Protection District ("Fire District") hereby certifies that the following is a true and correct statement of the results of the coordinated election conducted by Elbert County ("County") on November 3, 2009, as reflected in the Official Abstract Of Votes certified by the County's Board of Canvassers to the Fire District.

The votes cast for and against the ballot issue submitted by the Fire District were as follows:

BALLOT ISSUE 5D

SHALL ELIZABETH FIRE PROTECTION DISTRICT TAXES BE INCREASED \$272,500 (FIRST FULL FISCAL YEAR DOLLAR INCREASE) ANNUALLY BEGINNING IN LEVY YEAR 2009 (COLLECTED IN 2010) AND ENDING AFTER THE LEVY IN YEAR 2016 (COLLECTED IN 2017) BY INCREASING THE DISTRICT'S EXISTING TAX BY 1.97 MILLS TO BE USED FOR:

- NECESSARY UPGRADES TO FIRE STATIONS 1, 2 & 3;
- PURCHASE OF TWO STRUCTURAL FIRE ENGINES;
- PURCHASE OF TWO WILD LAND FIRE TRUCKS;
- PURCHASE OF TWO EMERGENCY MEDICAL AMBULANCES;
- PURCHASE OF TWO INCIDENT COMMAND VEHICLES;
- UPDATE APPARATUS & FIREFIGHTER SAFETY EQUIPMENT;

PROVIDED, THAT FOR THE 8 YEARS THIS CAPITAL IMPROVEMENT TAX IS IN PLACE, THE REVENUE FROM THE 1.97 MILLS AND ANY EARNINGS ON THIS TAX SHALL CONSTITUTE A VOTER-APPROVED REVENUE CHANGE WITHIN THE MEANING OF ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION AND AN EXCEPTION TO THE LIMITATIONS SET FORTH IN SECTION 29-1-301 OF THE COLORADO REVISED STATUTES, AND ANY OTHER LAW?
