

SHALL FLORISSANT FIRE PROTECTION DISTRICT TAXES BE INCREASED \$101,808 ANNUALLY, OR BY SUCH AMOUNT AS MAY BE RAISED BY THE IMPOSITION OF AN ADDITIONAL AD VALOREM PROPERTY TAX RATE OF UP TO 2.000 MILLS, COMMENCING WITH THE COLLECTION YEAR BEGINNING JANUARY 1, 2010, AND CONTINUING THEREAFTER, FOR GENERAL OPERATING PURPOSES, INCLUDING BUT NOT LIMITED TO REPLACEMENT OF ENGINES AND OTHER VEHICLES THAT ARE APPROACHING OR ARE AT THEIR RECOMMENDED USEFUL LIFE, RESULTING IN A TOTAL DISTRICT GENERAL OPERATING MILL LEVY RATE NOT TO EXCEED 6.85 MILLS, EXCLUSIVE OF REFUNDS, ABATEMENTS, CAPITAL IMPROVEMENTS AND DEBT SERVICE; AND SHALL THE DISTRICT BE AUTHORIZED TO COLLECT, RETAIN AND SPEND ALL TAX REVENUE COLLECTED FROM SUCH INCREASED PROPERTY TAX RATE, COMMENCING JANUARY 1, 2010, AND CONTINUING THEREAFTER, AS A VOTER-APPROVED REVENUE CHANGE, OFFSET AND EXCEPTION TO THE LIMITS WHICH WOULD OTHERWISE APPLY UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION, OR ANY OTHER LAW, AND AS A PERMANENT WAIVER OF THE 5.5% LIMITATION UNDER SECTION 29-1-301, C.R.S.?
