A RESOLUTION AFFIRMING THE DESIGNATED ELECTION OFFICIAL'S ACTIONS IN CANCELLING THE 2010 BIENNIAL ELECTION OF DIRECTORS PURSUANT TO SECTION 1-5-208(1.5) C.R.S.

WHEREAS, pursuant to Section 1-5-208(1.5) C.R.S, if the only matter before the electors in a non-partisan election is the election of the persons to office, and

WHEREAS, if at the close of business of the 63rd day before the election, there are not more candidates than offices to be filled at the election, including candidates filing affidavits of intent to be a write in candidate, the Designated Election Official, if instructed by resolution of the governing body, shall cancel the election and declare the candidates elected, and

WHEREAS, Resolution 2010-07 designated Jeffrey A. Blue as the Designated Election Official and gave him the authority to cancel the election if the conditions of Section 1-5-208(1.5) were met, and

WHEREAS, on March 2, 2010, he determined that the conditions of Section 1-5-208(1.5) had been met and he canceled the election, published notice of the cancellation of the election, and notified the candidates and the Board of Directors of his action.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE FREMONT SANITATION DISTRICT THAT THE ACTIONS OF THE DESIGNATED ELECTION OFFICIAL ARE AFFIRMED.


