A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MID VALLEY  
METROPOLITAN DISTRICT APPOINTING A DESIGNATED ELECTION  
OFFICIAL AND AUTHORIZING THE DESIGNATED ELECTION OFFICIAL  
TO CANCEL THE ELECTION

WHEREAS, pursuant to C.R.S. § 32-1-804(2), the Board of Directors of the Mid Valley Metropolitan District located in Eagle & Garfield Counties, Colorado is authorized to designate an election official to exercise the authority of the Board in conducting the election, and

WHEREAS, pursuant to C.R.S. § 1-5-208, the Board can authorize the Designated Election Official to cancel the election upon certain conditions;


NOW THEREFORE, be it resolved by the Board of Directors of the Mid Valley Metropolitan District of Eagle and Garfield Counties, Colorado that:

1. The Board hereby names William Reynolds as the Designated Election Official for the regular district election scheduled for the 4th day of May, 2010.
2. The Board hereby authorizes and directs the Designated Election Official to cancel said election and declare the candidates elected if at the close of business on the sixty-third day before the election there are not more candidates for director than offices to be filled, including candidates filing affidavits of intent to run as write-in candidates.
3. The Board further authorizes and directs the Designated Election Official to publish and post a Notice of Cancellation of Election at each polling place and in the offices of the Designated Election Official, the county clerk and Recorder of Eagle and Garfield Counties, and file with the Division of Local Government. The Designated Election Official shall also notify the candidates that the election was cancelled and they are elected by acclamation.

Read and adopted this 20<sup>th</sup> day of January, 2010, by the Board of Directors of the Mid Valley Metropolitan District by a vote of 4 to 0.
