WHEREAS, pursuant to 32-1-804(2), C.R.S., the Board of Directors of the Rio Grande County Ambulance District, Rio Grande County, Colorado is authorized to designate a Designated Election Official to exercise the authority of the Board in conducting the election, and

WHEREAS, pursuant to 1-5-208, C.R.S., the Board can authorize the Designated Election Official to cancel the election upon certain conditions;

NOW THEREFORE, be it resolved by the Board of Directors of the Rio Grande County Ambulance District, Rio Grande County, Colorado that:
