

To Whom It May Concern:

In the past, current listings of directors, with addresses, were literally filed with you within 30 days of the cancellation of election and declaration deeming candidates elected. This year we were advised by the Department of Local Affairs not to file with them the Cancellation of Election and Declaration Deeming Candidates Elected until 30 days after the date of the election canceled, which would be 30 days after May 4, 2010. This filing was overlooked and should have been made by June 3, 2010. Had it been made then, there would have been a vacant position on the Board of Directors. As of July 1, 2010, an appointment by the existing Board was made to the vacant Board position. As a consequence, as of this date, all five of the current directors of the District referenced above, names and residence addresses, are as follows:

In the right-hand column, the first two of the three directors listed were incumbent directors, re-elected pursuant to the cancellation of this statutory biennial election for directors May 4, 2010, each for a four-year term on the Board. The last director in the right-hand column above was just appointed to the Board to fill a vacancy on July 1, 2010, his Oath with the bond having separately been previously submitted to your office for filing. As to the two incumbent directors, separately submitted to your office previously were Oaths and bonds and the notice of the cancellation of election and declaration deeming those directors as candidates elected as directors.
