SANITATION DISTRICT APPOINTING A DESIGNATED ELECTION OFFICIAL  
AND AUTHORIZING THE DESIGNATED ELECTION OFFICIAL TO CANCEL  
ELECTION

WHEREAS, pursuant to C.R.S. §32-1-804(2), the Board of Directors of the Spring Valley Sanitation District is authorized to designate an election official to exercise authority of the Board in conducting an election; and

WHEREAS, pursuant to C.R.S. §1-5-208, the Board can authorize the Designated Election Official to cancel the election upon certain conditions.

NOW THEREFORE, be it resolved by the Board of Directors of the Spring Valley Sanitation District that:

1. The Board hereby names Denise Diers as the Designated Election Official for the regular district election scheduled for the 4<sup>th</sup> day of May, 2010.

2. The Board hereby authorizes and directs the Designated Election Official to cancel said election and declare the candidates elected if at the close of business on the sixty-third day before the election there were not more candidates for directors than offices to be filled, including candidates filing affidavits of intent to be write-in candidates. The Board further authorizes and directs the Designated Election Official to publish and post notice of the cancellation at each polling place and in the offices of the Designated Election Official, Clerk and Recorder of Garfield County and file with the Division of Local Government. The Designated Election Official shall also notify the candidates that the election was canceled and they were elected by acclamation.


