



**JUDGES' CERTIFICATE OF ELECTION RETURNS AND
STATEMENT OF BALLOTS**

**GRAND VALLEY FIRE PROTECTION DISTRICT
GARFIELD AND MESA COUNTIES, COLORADO**

IT IS HEREBY CERTIFIED by the undersigned who conducted the election held in the Grand Valley Fire Protection District, Garfield and Mesa Counties, Colorado, on the 2nd day of November, 2010, that after qualifying by swearing and subscribing to their Oaths of Office, they opened the polls at 7:00 a.m., and that they kept the polls open continuously until the hour of 7:00 p.m. on said date, after which they counted the ballots cast for and against Ballot Issue A:

"IF AND ONLY IF AMENDMENT 60 IS APPROVED BY THE VOTERS DURING THE NOVEMBER 2, 2010 STATEWIDE GENERAL ELECTION, AND WITHOUT CHANGING ITS CURRENT PROPERTY TAX RATE, SHALL THE GRAND VALLEY FIRE PROTECTION DISTRICT BE AUTHORIZED TO COLLECT, RETAIN AND SPEND ALL MONEY COLLECTED FROM PROPERTY TAXES AND ALL OTHER REVENUE SOURCES, BEGINNING IN COLLECTION YEAR 2011 AND ENDING AFTER COLLECTION YEAR 2014, AS A VOTER APPROVED EXCEPTION TO THE REVENUE AND SPENDING LIMITS OF ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION (AS MODIFIED BY AMENDMENT 60), THE 5.5% PROPERTY TAX LIMITATION OF SECTION 29-1-301, COLORADO REVISED STATUTES, AND THE REVENUE AND SPENDING LIMITS OF ANY OTHER STATE LAW?"
