

This is to notify you that the Department of Local Affairs' Division of Local Government (Division) has not yet received a copy of the Board of Canvassers' Certificate of Election Results, or a copy of the Notice of Cancellation from your district's May 4, 2010, regular biennial election required pursuant to C.R.S. § 1-11-103 and 1-5-208.

Please check your records and provide us with a copy of the Board of Canvassers' Certificate of Election Results or Notice of Cancellation as soon as possible to properly finalize the election. If the Division does not receive this election result certification, the Division may file for the District's dissolution by administrative action pursuant to C.R.S. § 32-1-710(1)(a)(I).

As a reminder, within 30 days following the date of each regular election, please file the following:

- Board of Canvassers' Certificate of Election Results or a copy of the Notice of Cancellation
- Copy of an Oath and individual, schedule, or blanket surety bond for each newly elected director
- District's business address, telephone number, and contact person
- If applicable, the language for any ballot issue or ballot question voted at the election.

Please note, if any director fails to take the oath or furnish the requisite bond within 30 days of being elected or appointed as a director, their office shall be deemed vacant, and the vacancy thus created shall be filled in the same manner as other vacancies in the office of the director (C.R.S. § 32-1-905).

Other missing election related information for this district may be identified by the "Special District Directors" report on the back of this letter. If any of this information is either incomplete or inaccurate, please forward the appropriate documents using the Division's electronic filing instructions or by mail. Following the Division's receipt and processing of any missing documents, you may view an updated "Directors Report" for your district.






