





WATER RIGHTS, INFRASTRUCTURE AND OTHER IMPROVEMENTS (THE "WATER SYSTEM") IN ORDER TO PROVIDE WATER SERVICE TO THE PARK AND RECREATION PROJECT, AND

(2) ALL NECESSARY, INCIDENTAL, AND APPURTENANT FACILITIES, EQUIPMENT, LAND, EASEMENTS AND EXTENSIONS OF AND IMPROVEMENTS RELATED TO SUCH WATER SYSTEM;
