

 'Number of directors' will be boxed if the number of directors is not 5 or 7.
- The district must have one director listed as chair.
 'Chair' will be boxed if no director is identified as the chair or if more than one chair is identified.
- Each director must have a valid, unexpired term.
 A director's 'Term Expires' will be boxed if their term is missing or ends during or prior to the current year.
 Please remember director positions should be staggered; a 5 member board has three four year terms up for one election and then two four year terms for the following election. However, due to appointments to vacancies several directors or even the entire board may be required to run for election at the same time for a combination of four year terms and two year terms.
