
Dear Mr. McConnell:

NOTICE OF CANCELLATION



**A RESOLUTION OF THE JULESBURG FIRE PROTECTION DISTRICT
APPOINTING A DESIGNATED ELECTION OFFICIAL AND AUTHORIZING THE
DESIGNATED ELECTION OFFICIAL TO CANCEL THE ELECTION**


WHEREAS, pursuant to 32-8-804 (2) C.R.S., the Board of Directors of the Julesburg Fire Protection District, Sedgwick County, Colorado, is authorized to designate a Designated Election Official to exercise the authority of the Board in conducting the election; and

WHEREAS, pursuant to 1-5-208 C.R.S., the Board of Directors can authorize the Designated Election Official to cancel the election upon certain conditions.


NOW, THEREFORE, be it resolved by the Board of Directors of the Julesburg Fire Protection District, Sedgwick County, Colorado, that:

1. The Board hereby names Muriel L. Nelson the Designated Election official for the regular district election scheduled for the 8th day of May, 2012.
2. The Board hereby authorizes and directs the Designated Election Official, if the only matter before the electors is the election of persons to office, to cancel said election and declare the candidate elected, if at the close of business on the sixty-third day before the election there are not more candidates than offices to be filled, including candidate filing affidavits of intent to run as write-in candidates.
3. The Board further authorizes and directs the Designated Election Official to publish and post a Notice of Cancellation of election at each polling place and in the offices of the Designated Election Official, the County Clerk and Recorder of each county in which the district is located and file the same with the Division of Local Government. The Designated Election Official shall also notify the candidates that the election was cancelled and they are elected by acclamation.
