To Whom It May Concern:

As the attorney and designated election official for the District, pursuant to statute, I hereby file with you the Cancellation of Election and Declaration Deeming Candidates Elected.

Following that, enclosed are the Oaths for the three individuals, together with faithful performance bonds, originally signed by the candidates (now the newly elected directors) and notarized. The terms, of course, run from May of 2012 to May of 2016 for the two directors elected to four-year terms and from May of 2012 to May 2014 for the one candidate elected by acclamation as a director for a two-year term.

An originally signed duplicate of this Cancellation of Election and Declaration Deeming Candidates Elected was hand-delivered to each of the candidates, now newly elected directors, on March 8, 2012, and on March 9, 2012, posted in the designated election official's office, with the Arapahoe County Clerk and Recorder, and at the two polling places to have been used for voting on May 8, 2012, had the election proceeding according to schedule, Polling Place No. 1, Cherrelyn Elementary School, at 4550 S. Lincoln St., Englewood, Colorado 80110, and Polling Place No. 2, Highland Elementary School, at 711 E. Euclid Ave., Littleton, Colorado 80121.

Additionally, the Cancellation of Election and Declaration Deeming Candidates Elected, together with individually signed Oaths, accompanied by faithful performance bonds, for the three candidates elected as directors, was mailed on this date to the Arapahoe County District Court Clerk for filing in the District Court in Arapahoe County, Colorado, in Case No. 9318, "In Re the Organization of South Englewood Sanitation District No. 1."


Finally, the Cancellation of Election and Declaration Deeming Candidates Elected was remitted, to be published in the Englewood Herald on April 6, 2012.
